

the Confort of the freedmen of this Province by their severall delegates and representatives by them freely nominated chosen & elected to serve for their severall Cities & Countys in a Generall Assembly done forasmuch as the safest & best rule for this Province to follow in electing such Delegates & representatives is the president of the Proceedings in Parliament in England as neare as the Constitutione of this Province will admitt the Delegates of this present Generall Assembly doo humbly pray That it may be enacted and bee it enacted by the Right Hon: the Lord Proprietarij by and with the advice and consent of the upper and lower houses of this present Generall Assembly and the Authoritie of the same That for the future whenever as often as his Lordshipp the Lord Proprietarij his heires and successors his or their Lieutenant & Chiffe Governour for the time being shall upon any accidente & urgent affaires of this Province think it fitte convenient to call, convene an Assembly and to send out writs for the election of Burghes & Delegates to serve in such Assembly the forme of the said writt shall be as followeth C: Absoluto Lord and Proprietor of the Province of Maryland, — Avalon Lord Baron of Baltimore To thd Sheriff of A: Greeting these are to — Authority and Required you imediately upon Receipt hereof to call together four or more of the Commissioners of your County with the Clerks who are hereby required to sit as a Court and during their sitting by vertue of your office to make or cause to be made Publick Proclamation thereby giving notice to all the freedmen of your said County who have within your said County a freehold of fifty Acres of Land or a visible personall estate of forty pounds Starling att least Requiring them to appear at the next County Court to be holden for your County att a certaine day within a reasonable time after such Proclamation made for the electing & chusing of Delegates and delegates to serve for your County in a Generall Assembly to be holden att the fifte of St Marys the Day of at which time of Proclamation aforesaid the said freedmen soe Required to appear or the Major part of such of them as shall then appear shall and may and are hereby Authorized and Required to elect and chuse four severall sufficient freedmen of your County each of them having a freehold of fifty Acres of Land or a visible personall estate of forty pounds Starling att least within your County and you shall give Authority to each of them severally and respectively by four severall and respective Indentures vnder their hands and Seals to be Deputyes & Delegates for your County and to apppear and serve as Deputyes and Delegates for your County att the said next Generall Assembly to doe and Confer to those things which then by the favour of God shall then happen to be ordained by the Lord Proprietarij by the advice and Confort of the great Council of this Province concerning such occasions and affaires as shall relate to the Government State and defence of this Province but wch will not in any case that you or any other Sheriff in our said Province be elected which said Indentures shall be betwixt you the Sheriff of this one part and the said freedmen electing on the other part and shall beare date the same day upon which the said Election shall be made and shall mention the time and place of such election
