

And the persons soe elected and shall be signed and sealed each part of them as
 well by you the Sherriffe as by the said freemen by whom the said Election shall
 be made and that upon such Election you the Sherriffe shall soe soon as
 conveniently may be certified and transmit to the Chancellor of this Province for
 the time being one part of the said severall & respective Indentures close
 sealed up under your hand & Seals and directed to the Lord Proprietary of
 this Province and also to the said Chancellor & the other part of the said Indentures
 you are to keep for your Justification with our selfe att our City of St. Maryes
 &c. And be it further enacted by the Lord Proprietary by and with the consent
 of the upper and lower houses of this present Generall Assembly and the
 Authority of the same that two Citizens to serve in the said Assembly for the
 City of St. Maryes be nominated elected chosen and appointed by the Major Recorder
 Aldermen & Common Council as heretofore hath been usuall And Be it further
 enacted by the Authority aforesaid that the aforesaid four Delegates to be
 elected in the severall Counties within this Province and the two Citizens of
 the said City of St. Maryes be and are hereby bound and obliged to attend at
 the time and place of the meeting of such Assembly without any further writt or
 Summons to be to them. And under the penalty of such fines as shall be by
 the lower house of Assembly imposed upon them unless upon sufficient
 Excuse to be admitted by the said lower house of Assembly their absence
 be dispensed withall any Statute law or Usage to the contrary therof in
 any wise notwithstanding. And Be it also enacted by the Authority aforesaid
 that any Sherriffe that shall refuse or neglect to make returns of the Delegates
 soe elected by Indenture as aforesaid before the day of sitting of such Assembly
 or that shall make any undue or illegall returns of such Elections shall for
 every such default be fined one hundred pounds Sterling one halfe to
 the Lord Proprietary the other halfe to the informer or him or them that
 shall sue for the same to be recovered in any Court of Record in this Province
 wherduin noe Essoyn protection or wager of Law to be allowed Provided
 Nevertheless that this Act or any thing therein contained shall not extend to
 or be construed to exclude any County or Counties City or Cities Burrough or
 Burroughs hereafter by his Excellency the Lord Proprietary of this Province
 his heirs & Successors to be directed appointed and made within this Province
 from the benefit and liberty of such Elections of Delegates and representatives
 as is before expressed but that such writt as aforesaid shall upon calling every
 Generall Assembly for this Province for the future be issued to the Sherriffe of every
 such County when the same shall be directed and made into a County as aforesaid
 and to Major Recorder and Alderman of such City or Burrough commanding
 such Sherriffe or Major Recorder & Alderman to cause four freemen of the same
 County & two freemen of the said City or Burrough qualified as in the said
 writt is expressed to serve as Delegates and representatives of the same County
 City or Burrough in the Generall Assembly then next ensuing which said four
