File and respectively, by four feveral and respective Indentures under cheir File and and Seals to be Deputy's and Delegates for your Gouney at the fact next General Assembly, to do and condent to those things, which then by the Favour of God shall aspine to be Ordained by the Advice and Comfont of the great Contained that Province, that we will not many the factor of this Province, that we will not many the factor of the one part, and the fail to be seen that the fail of the one part, and the fail of the fail Election shall be made, and that upon such Election, you the Sherrif shall so soon as conveniently may be, Certific and Transmit to the Chancellor of this Province for the time being one part of the said several and respective indentures, close Sealed up under your Hand and Seal, and directed to the Governour of this Province, and also to the Chancellor; and the other part of the said indentures you are to keep for your Justification. And Be it Further Enacted by the Authority aforefaid, That two Citizens to Serve in the said Assembly for the City of St. Marys, to be Nominated, Elected, Chosen and Appointed by the Mayon, Recorder, Aldermen and Common Council

as liererofore hath been usual.

And Be It Further Enacted by the Authority sloresaid. That the asoresaid sour Delegates to be Elected in the Respective County's within this Province, & the a Cityzens of the City of St. Mary's, be and are hereby bound and obliged to attend the time and place of the meeting of such Assembly without any surther Write or Summons to be to them sent, under the penalty of such Fines as shall be by the House of Assembly imposed upon them, unless upon sufficient Excuse to be admitted by the said House of Assembly their Absence to be dispensed withall, any saw Statute Usuage or Custom to the contrary notwichstanding

And Be It also knacked by the Authority aforesaid. That any Sherrif that Resuse and Neglect to make Return of the Delegates so Elected by Indenture as aforesaid, before the Day of Sitting of such Assembly, or that shall make any undue or illegal Returns of such Elections, shall for every Fault be fined one thoughand pounds Sterling, the one half for their Majesty's for the Support of the Gameroment, and the other half to the Informer, or him or them that shall Sue ser the same, to be Recovered in any Court of Record in this Province, whereir no

Effoyn Protection or Wager of Law to be allowed.

Provided nevertheless, That this Act or any thing herein contained shall or Extend to be Constroed to Exclude any County or County's, City or City's Butrough or Burroughs hereafter by their Majelly's their Heirs or Successors to be Eloded and made within this Province, from the Liberty of fuch Elections of Delegaces and Representatives as is before Exprest; But that such Weite as aforesaid shall upon ealling every General Assembly for this Province for the future, to the Sherrif of every such County when the same shall be erected and made into a County as aforefaid, And to the Mayor Recorder and Aldernien of every fuch City or Burrough Commanding of fuch Sherrif or Mayor Recorder and Aldermen to cause sour Freemen of the faid County, and two Freemen of the said City or Burrough qualified as in the fuid Writt is exprest, to Serve as Delegares and Representatives of the fame County City or Burrough in the General Astembly then next ensuing, which said four Delegates for every such County, and two for the City and Eurrough shall from henceforth be Reputed and Estoemed to be Members of the House of the General Assembly of this Province, any thing in this Act to the contrary in any wife notwithstanding.

Provided also that no Ordinary Keeper within time Province during the term of his keeping Ordinary, shall be Elected, Chosen, or Serve as a Deputy or Representative in the said general Assembly, so to be largested Called, Convened and

appointed as aforefaid.
