Be it Enacted by the Kings most Excellent Majesty by and with the Advice and Consent of this present General Assembly and the Authority of the same, that if any person or persons whatsoever within this Province after the publication of this Act prophanely fwear or curle in the prefence or hearing of any one Justice of the Peace or other head Officer of any Town, City or Burrough within this Province, or that shall be thereof convicted by the Oath of one witness before any one Justice or other head Officer, or by confession of the party offending shall forseit and pay for fuch offence, the fum of five skillings. Sterling to our Sovereign Lord the King for the use of the poor of the County where the offence shall be committed, to be leavied upon fuch offender or offenders immediatly by Command or Warrant from such Justice of the Peace or head Officer of any Town, City or Burrough before whom fuch offeder or offenders shall be convicted, to the Constable or other person whom such Justice or head Officershall command or appoint, by distress or fale of his her or their Goods or Chattols, rendring to them the overplus, and in case any person should result to obey to execute the Command or Warrant of any Justice of the Peace or head Officer as aforefaid, in this case such person or persons shall forfeit and pay the Sum of five Shirlings to be leavied as aforefaid, to the use aforesaid.

Be in further Enacted by the Authority aforefuld, that for every time any perfon or perfore shall prophetely swear or curse, in any Court House during the fitting of any Court within this Province and be affected convict aforefaid, he she or they to offending that imediative forfeit and pay the fun of ten shillings as aforefaid to the uses aforesaid, or set in the Stocks for the space of one hour, by order

or command of any fuch Judice of the Peace or head Officer as aforefaid.

Provided allways, and it is hereby Enacted, that no person shall be prosecuted or troubled for any fuch prophane iwearing and curling, unless the fame be prov'd

or profequed within ten days next after the offence committed.

And My De it Engered by the Authority aforefaid, by and with the Advice and College aforesaid, that every suffice of the Peace or head Officer aforesaid, are leavied as aforefait, and render a just account thereof to the Justices of each respective Counry yearly, at the time of daying the Coupty.
