desperate deles with the division of the overplus of the estate unto the leveral and reflictive u ices of the County Cours where the Estate shall ly, to the end the faid wices may inquire whether the faid Administrator hack by fraud or otherwile negle 'ed to recouer the lame, or hath received and nover accounted for the fame, and hall with the residue of the faid Estate commit the said desperate debts to the care of the guardians or other trustees by them imployed and shall yearly and every year call the faid Guardians to account for the fame, and duly infirst what of the faid debts they have received or might have received, and if the faid guardian or tru ee fail to give in his account yearly, or by fraud or covia negle t or orbear to recover the fame, the faid guardian or trustee shall stand and be accountable for every such debt by themreceiv's & not accountedor negle Ceder aftern tobe recovered. 10. That the Justices of the County Courts take able & fufficient Socurity for Orphans Estates, and inquire yearly of the security, and if the relie in a cause that they require new and better security, Equpon resulal to give new & beiter security to remove the Orphans Estates into their hands. And further,

That the indices of the County Courts shall yearly in June Court inquire by a Jury of good and lawful Men to be furnoned out of the feveral Hundreds of the County not under the number of twelve, who upon their oaths thall inquire the form of which oath is hereby exprest, viz. Whether the Orphans be kept; mainramilie educated according to their estates, & whether apprentices yearly are taught their rade or rigorously used and turned to common labour at the Ax and Hoo instead of learning their Trades, and if they find that Orphans are not maintain'd and educated according to their Estates, or Apprentices neglected to be taught their I radas upon prerence that the last year is enough to leafn their trade, that they remove them to other guardians & mallers respectively, and in case the Jury find that any apprentice is not taught his trade but put to other labour as aforefaid, the County Court thall condomn the Mafter of fuch Apprentice to make the Apprintice then fictisia tion as in justice his years of labour at other work shall deferre, and we handred pounds of tobacco to be paid to the faid Orphan:

11. That the Julices of the County Courtscause the conditions of the Beade they take of guardians or truthees of Orphans chares be exactly drawn to the Act. and Recorded in the County Court and the Indentures for Apprentices likewife, rim it may only appear to the Indges whether Guardians Trustees and Masters do right and reviews Apprentices, and to the Country, that the Justices do right between them, and to that end that they confer he Clark of their Court to present the enry with a life of the Caphans and Appentices of their County evity June
