the Advice and Confent of this present General Assembly & the Authority of the same, that from & after the publication hereof no servant or servants what here's within this Province whether by Indenture or according to the cuitom of the country or hired for wages, shall travel by land or water ten miles from the house of his her or their Master Mistress or Dame without a most under their hands, or under the hand of his or their Overseer if any be, under the penalty of being taken for a runaway, and to suffer such penalty s as are hereafter provided against runaways.

vant or servants as aforesaid unlawfully absenting him her or them from his her contact faid Master, Mistress, Dame or Overseer shall serve ten days for every or a days absence, to be judged when such Master. Mistress or Dame shall bring their said servant before the Justices of the Provincial or County Court where the owner maiter or dame or overseer of such servant shall live during the sitting of the Court, be it before or after the expiration of such seraabrs such time of service by ladent-ture or otherwise.

And Be it further Enacted by the Authority aforetaid, that any perion or prostons wharfoever that shall wittingly and willingly detain any such tervant or servants unlawfully abienting him her or themselves as aforesaid, that she fined 50 pounds of tobacco for every night or four and twenty hours that such persons persons shall give entertainment to such servant or servants unlawfully absenting him her or themselves as aforesaid, the one half to his Majesty for the supported Government, and the other half to the informer or him or them that shall sue service same, to be recovered in any County Court of this Province by Action of delagation of information, wherein no essential protection or wager of Law to he allow'd.

And for the better discovery of runaways, it is hereby Enasted by the Authority aforesaid, that any person or persons whatsoever within this Province traveling out of the County where he she or they shall live or reside without a pass under the Seal of the said County, for which they are to pay ten pounds of subaccour one shilling in money, such person or persons if apprended not being sufficiently known, or able to give a good account of themselves, to be less to the distriction of judgment of such Magistrace or Magistrates before whom such person or persons as aforesaid shall be brought to judge thereof, and if before such Magistrace stall be deemed and taken as a runaway, and shall suffer such fines and penalty said is

hereby provided against runsways.

And for the better incouragement of all persons to seize and take up such rona-ways, it is Enacted by the Authority aforesaid, that all and every person or persons as associated, seizing or taking up such runaways traveling without passe, it all coresaid, not being able to give a sufficient account of themselves as associated shall have and receive two hundred pounds of tobacco to be paid by the owner or such sunaway so apprehended and taken up if a Servant, and if a Freeman & resuling to pay the same, then to make satisfaction by servitude or otherwise as the suffices of the Provincial or County Courts where such person shall be so apprended and taken up shall think fit, and surther, for the better discovery and incouragement of our. Neighbour Indians to seize, apprehend or take up any runaway servants. and bring them before some Magistrat, shall for a reward have a matchesat paid him or them or the value thereof which saidreward to be repaid & satisfied by the county where such person shall be apprended, and such runaway to reimburse the food County by servitude or otherwise as the Justices of the Provincial or county count shall think fit.

And Be it further Enacted by the Authority aforesaid, that at what time scover any of the said persons runaway shall be seized by any person or persons with it this Province, such person or persons so apprehending or seizing the same stand
