that shall sue for the same to be recovered in any County Court of this Province, by Action of Debt Bill Plain: or information wherein no Enloya Protection or Wager of Law to be allowed.

And for the better discovery of Runaways it is hereby surrher Ena tod by the Authority Advice & Content aforesaid, that any person or persons whatsoever within this Province travelling out of the County where he she or they shall reside or live (without a Pass under the Seal of the taid County) for which they are to pay ten paunds of Tobacco or one Shilling in Mony such person or persons it apprehended not being sife with ficiently known or able to give a good account of themselves shall be less to the discretion & judgment of such Magnitrate or Magistrates before whom such person or persons as aforesaid shall be brought to judge thereof, and if before such Magistrate such person or persons so taken up shall be deem'd & taken a Runaway or Runaways he she or they shall suffer such ines & penaltys as is hereby provided against Runaways.

And for better incouragement of all persons to seize & take up such Runaways it is not hereby surther Enacted by the Authority Advice and Consent aforesaid, that all and every such person or persons as aforesaid seizing or taking up such Runaways traveling without 'a les as aforesaid, not being able to give a sufficient account of themselves as aforesaid shall have & receive two hundred pounds of tobacco to be paid by the owner of such Runaway so apprehended & taken up, and if such Runaway or Runaways be not Servants & resuse to pay the same he she or they shall make satisfa tion by service tude or otherwise as the unices of the provincial & County Courts where such person

shall be so apprended & taken up shall think sit.

And for the better discovery and incouragement of our Neighbour Indians to feize apprehend or take up any Runaway pervants & bring them before a Magi rate they will for a Reward have a Marcheoat paid him or them or the value thereof, which faid Reward to be paid & fatisted by the County where such person shall be so apprehended, and such Runaway to reimburse the said County by servitudeor otherwise as the Julices of the Provincial or County Court shall think sit.

And

Be it fur ner Ena Red by the authority advice & consent aforefail, that at what time Aircian and he foever any of the faid persons Runaways shall be seized by any person or persons within this Province tuch person or persons so aprehending or seizing the same shall bring of cause him her or them to be brought before the next Magi trate or suffice of the Count ty where such Runaway is apprehended, who is hereby impower'd to take into custody or otherwise him her or them to secure & dispose as he shall think fit until such pers so i or partons so seized & apprehended hall give sufficient security to answer the premiles the next Court that hall fir t enfue in the faid County which Court shall secure & fuch person or persons tube or they can make satisfaction to the party that hall so ap- guaraway fell prehend or teize fich Runaways or other perions as by this Act is required except fuch person thall make saissa tion as aforesaid before such Court thall happen, and that no- grafite to the their for Rice may be ronveniently given to the Maiter Miltress Dime of Overseer of Runaways taken up as aforesaid the Commi noners of the Countys shall forthwith cause a Noas hele lo be Afri of he Rungways Nime so seized & apprehended as aforesaid to be set up at the next adjacent ounty Courts and at the Provincial Court & Secretarys Office that all perfons may view the sam- & see where such rheir Servants are and in whose custody.

And furthermore for aftertaining what each Servant according to the custom of the Country stall have at the expiration of their fervitule, Be it Enasted by the Authority Advice & Consent aforesaid, that every Man Servant hall at such time of expiration of his servitude as aforesaid have allowed & given him one new Hatt a good Suit (that is to say) Coat & Britches either of Kersy or Broad Cloth one new Shift of white Linenen one new pair of French Fall Shoes & Stockings two Hoes & one Ax and one Gun of twenty Shillings price not above sour foot by the Barrel nor less than the eard an half, which taid Bun shall by the Master or Mistress in the presence of the next suitice of the Peace be delivered to such Freeman under the penalty of 500 pounds of tobacco on such Master or Mistress omitting so to do, & the like penalty on the said freeman selling or disposing thereof within the space of twelve Months, the one half whereof to our Sovereign Lady the Queen the other to the Insormer, all Woman Servants at the expiration of their servicude as afore said shall have allowed & given them a Wasteoat & Petrycoat of new half Thick or Pennystone a new Shift of white Linnen Shoes and Stockings a blew Apron two Capps of white Linnen & three Barrels of Indian Corn.

And be it further Ena ted by the Authority Advice & Confent aforesaid, that no person what something trade barter commerce or any ways deal with any Servant when the light or indented or Slave belonging or appetraining to any inhabitant within this Province without leave or license first had be obtained from such Servants Matter of Militals Dame or Overseer for his so doing under the Penalty of two thousand pounds.
