An Ad for Jecuring Merchants and others Tobacco after they have received it.

Be it Ina Red by the Queens most Excellent Majesty by & with the Advice and Consent of her Majestys Governour Council & Assembly of this Province and the Authority of the same, that from & after the publication hereof every Housekeeper & Inhabitant within this Province having a Plantation whereon he maketh or causeth to be made any I obacco shall build & er & or otherwise fit up & make ready a good tight House with a good Door Lock & Key upon every Plantation where such tobacco is made as aforesaid and sufficient to contain the tobacco made on every Plantation.

And be it further knasted by the authority aforefaid that eviry Inhabitant or House-keeper as aforefaid having a Plantation whereon he make the or cause he to be made any tobacco as aforesaid & that shall pay away & dispose of any tobacco to any Merchant matter of ship failor or any other perfore whatever shall not withstanding such disposare or payment secure & keep the said tobacco as he would do his own proper goods for & during the space of one whole Year commencing from the time the tobacco was received as a foresaid and if any tobacco so received as aforesaid for want of such house shall make so issa from to the party that received the same.

Provided always that or House A contained shall be construed meant and intended to make any Inhabitant or House keeper lyable to any damage which shall or may happen to any to

bacco fo left with him to keep fecure through any other cafualty whittoever.

And be it Fina bed by the Authority aforefaild by & with the Advice and Confent aforefaid, that any perion or perions wha foever Merchants or others within this Province that have at any time within twelve Months la t pad received marks or nail'd or for the future thalf receive mark or nail any liogitead or hogiteads of tobacco within this Province of any perfor or perfors debtors within the fame and which hith been paid & deliver deo hem for facisfaction of their faid debts & tuch Merchants or others Live upon recent marking & nailing such hh'd or hh'ds of tobaco deliver'd up their Bills or other fourity to their respedive debtors of their said debts, or if the said Merchants trothers have given releases or discharges to their faid debrors of the said debt and that before the faid Merchant or others could remove the faid hog'head or hog'heads o' tobacco from the fail debtors tobacco houses it any Sheritthall come and soize such to bacco fo markt & nail'd as aforefaid, that then and in eviry such case if the party refish to make and give to the faid creditors some other full fatisfa tion for their faid debis it shall & may be lawful for any two of hir Majetys in lives of the respective County's within this Province upon due proof thereof ande before them of the fail d be and Sherifs feizure as aforefaid and the party debtor refuling to make that full fatisation to their creditors for their faid dibts at the faid creditors request to a ward him Execution with coils fuch coils not exceeding one hundred pounds of tobacco against the hody goods & chattels of fuch debtor to be executed by the Sheriffor farisfaction of the creditors just debt & costs as aforesaid in as full & ample manner as if the debt were recovered by due courfe of Law.
