being shall see cause to order & that cy ty such Colonel Major or Captain shall give notice or summons upon every training or mustering to every person so childed as a sore-said within his respective Division or Limit at the head of his company or as the house of the party by an Officer of his company or Warrant under his hand to appear at such time & place as he shall appoint for such training or multering, and that if any Man after such notice given & summons as asoresaid shall neglect to appear at the place and time appointed as aforesaid or that refuse when he hath so appeared to be enlisted into the Militia & Trainbands aforesaid or that being so enlisted shall not from time to time as he shall be summoned or warned as aforesaid to appear & bring with him one good. serviceable Gun fixed with six shorts of powder shall for every such offence (if a Freeman forseit and pay the sum of one hundred pounds of tobacco and if a Servant letted or hidred by his Master Mistress or Overseer then such Master Mistress or Overseer to pay the like sum of one hundred pounds of tobacco for every Servant so letted or hindred as aforesaid for theuse of the Foot Company to putchase Drums Colours & other · necessarys for the Company as the Commander thereof shall direct. Provided that this clause be not construed to countenance any Officer to press Arms or Ammunition for 2ny further Expedition or Service than training bur that upon all such occasions they shall be supplyed out of the County Magazine or Store, all which Forseitures shall be adjudged heard & determined by such Colonel Major or Captain of any Foot Company as aforesaid and account thereof kept in writing by the Clerk of such Company which faid Colonel Major or Captain of fuch Company as aforesaid is hereby authorized & impowered to award Execution against the goods & chattels of such persons to neglecting refusing or failing as aforesaid, and that upon c ccasion of all such Fxecutions the respective Clerks and Sherifs of each respective County within this Province thall iffue out and terve Execution without Fee or Reward.

And for fettling the Horse Forces, That a Captain of Horse in each respective Coun ty for making up of his Troop elect and enlift his number of Men out of the inhabitants of the faid County according to fuch instructions as he shall from time to time re ceive from the Governour of this Province for the time being. Provided always that fuch Froopers thall Ride their own Horses, and that no person shall be a Trooper without he be owner of a good serviceable Horse which shall pass Muster, and that tuch Troopers in confideration of their great pay hereaster to be allow'd be bound & obliged to find themselves with good able & sufficient turniture for their Horses & likewife to find themselves with Swords Carabines Pistols Holsters & Ammunition, and if any Troopers shall neglect or resuscupon notice given them as aforesaid to the Foot to appear at Muster at the time and place apppinted as aforefaid by each respective Captain of Horse accounted as aforesaid required as aforesaid shall sorfeit and pay the one hundred pounds of robacco to be levyed as aforefaid to the use of the Troop for the purchasing of Trumpets & Colours and other necessarys as the Commander shall think fit, and that all fuch Troopers for and in confideration aforesaid at all such times as they are out a ranging shall find their own provisions, but when in a stual service to be found provisions at the charge of this Province to be paid by the Publick, and if it shall happen that any Troopers Horse shall be kill'd in the service then the said Trooper to be paid for the faid Horse by the publick and not otherwise. That all persons in Holy Orders Delegates Magistrates & Constables shall in their proper persons be exempted from being compell'd to multer and train either in Horse or Foot during such time as they officiate or bear such Offices as aforesaid. Provided that this clause shall extend to fuch persons as already have or shall hereaster accept of Commissions for military service from the Governour of this Province for the time being so as to discharge such persons from their respective charges mentioned in such their several and respective Commissions.

And be it Enacted by the Authority aforesaid that all Negroes & Slaves whatsoever shall be exempted the duty of training or any other military service. That the pay for the Officers and Soldiers of the Foot & Horse aforesaid be not other than is hereafter montioned and for no longer time than such Officers & Soldiers shall be in actual services in Foot 2000 pds of tobacco per Month, to a Major of Foot 2000 pds of tobacco per mo: to a Captain of Foot 2000 pds of tobacco per mo: to an Ensign 600 pds of tobacco per mo: to a Corporal 400 pds of tobacco per month; to a Seriezne 400 pds of tobacco per month, to every private Soldier 300 pounds of tobacco per month, to every private Soldier 300 pounds of tobacco per month; to every Major General chief Commander in the Field 3000 pounds of tobacco per month, a Major of Horse have 2300 pounds of tobacco per month, a Major of Horse have 1500 pounds of tobacco per month, a Lieutenant of
