(76)ested in the Lands lying within the County aforesaid at such places within the said County as they or any three or more of them thall think fit from time to time with or without any adjournment summarity and without the formality and proceedings in Courts of Law or Equity cither upon the verdict or inquisition of surors Testimony of Witnesses upon Oath examination of partys interested or by all or any the faid ways (or otherwise according to their discretion) and that the judgment or sentence of the faid Commillioners or any three or more of them as aforefaid shall be final between the faid partys their Heirs Executors Administrators & Assigns and all claiming by from ar under them touching the matters & decrees to be made by the find Commi noners by this prefent Act thereunto authorized or any three or more of them the faid Comminioners always giving timely notice of not less than sixteen days of the time & place of their fitting saving the right of all persons under age non sanæ Memoriæ Feme Coverrs and persons non Resident within this Province during such time as they shall continue To, who shall and are hereby allowed to profecute their claims within twelve Months after fuch disabity removed and unless any party distatisfied with such sentence shall appeal thereftom within thirty days to fuch Commissioners as his Excellency the Governour for the time being is hereby impower'd to authorize and appoint by his Commillion for that purpose under the great seal of this Province not exceeding sive in number whereof the major part of all fuch Commissioners meet or two in case only three meet shall finally determin thereon in minner aforesaid without any further Appeal or Review.

And he it Ena Ted that the faid Commi lioners be & are hereby impower'd to commit & punish by Fine not exceeding one thousand pounds of tobacco all such persons who shall disturb the fitting of the faid Commissioners or wilfully refuse to give evi-And further for the better discovery of persons Rights to Lands claimed before the said Commissioners, the faid Commissioners or any three or more of them may & are impowered to i 'ue Precepts to the Sherif & surveyor of the faid County to refureey and make returns to the said Commi concrs pursuant to the tenor of such Precepts & Warrants which the faid Sherif & Surveyor shall & are hereby obliged to execute for such reasonable lees as to the faid Commissioners hall seem meet, and also the said Commissioners shall & may make & chablish luch renfonable Table of Fees to their Clerk whom they are to make choice of with the approbation of his Excellency for the Writing & Recording of any marters before them and to the Sherif of the faid County who is hereby injoyned by his sufficient deputy contantly to attend them and serve & execute all Precepts Warrants Orders Notices in Writing or other Summons as by the faid Commidioners to the faid Stierif hall be directed not exceeding one full movery in proportion to what is allowed by the Act of Atlembly for limittation of Officers Fees to the feveral Sherifs and Clerks of the County Courts which Fees are to be upon Execution as other Fees belonging to Clerks and Sherifs.

And be it further English that the judgments & deter minations which shall be made betwirt party and party by authority of this Act shall be recorded in a fair dook or Books to be provided for that purpose at the County charge, and every such judgment and determination shall be figued by three or more of the said Commissioners which Book or Books when perfected shall be placed & intru ted in the custody of the Clerk of Arx-Arundel County among the Records of the faid County that all persons concerned may repair to view the fame, And further that none of the said Comm finners shall take any Fee or Reward whatsoever directly or indirectly for any thing to be done by them by vertue or colour of this present A & saving the allowance of eighty pounds of tobacco per diem for their expences during the time as they shall sit to hear & determin such claims, which charge the Commillioners of Ann-Arundel County are hereby authorized & obliged to levy & affefs upon the several taxables of the faid County and allow unto them in the County Levy:

And provided nevertheless that it shall be lawful for the Commissioners by this A & impowered to affets & exact fuch reasonable charges on all persons non residents in the faid County and making claims before them as in their differetion they shall think its accounting therefore to the County Levy, and that the said Commissioners are hereby impowered to make all necessary Rules & Orders for the better carrying on all busneis that shall be brought before them and the good and regular government of their Court.

And be it further Enasted by the authority advice & confent aforesaid that the Julia ccs & Commissioners of Ann-Arundel County Court for the time being be impowered according to their discretion upon application to them made and due proof thereof w affirm all judgments hererofore given in the faid County Court now unfatisfied and at 47.62
