

ward Execution thereon and again to adjudge & ascertain the times of service of all orphans by them bound out and servants according to Act of Assembly heretofore by them adjudged whereof the Record is not extant but burnt as aforesaid as in their Writings they shall think fit, and that for the entries of such judgments & all matters there to relating the Clerk of the said County be allow'd but half fees, any Act Law usage or custom to the contrary notwithstanding.

An Act empowering Major *Nicholas Low* Executor of the last Will & Testament of *William Edmondson* late of *Dorchester County* deceased to sell a certain Tract of Land lying in *Dorchester County* called *Richardsons' Choice* formerly purchased by the said *William Edmondson* of & from one *John Nichols* for payment of a debt due from the said *William Edmondson* to the said *John Nichols* for the remaining part of the original purchase for the said Land.

An Act confirming a certain Letter of Attorney from *William Joseph Esq^r* the Father to *William Joseph* his Son.

An Act for the Exportation & Banishment of *Benjamin Cely*.

An Act for the Outlawing of *Richard Clark* of *Ann-Arundel County*.

An Act for punishment of persons selling or transporting any Friend Indian or Indians out of this Province.

TO the End that no breach of peace may happen between the Neighbouring Indians and the Inhabitants of this Province,

Be it Enacted by the Queens most Excellent Majesty by & with the Advice & Consent of her Majestys Governour Council & Assembly of this Province & the Authority of the same that any person or person whatsoever that shall take, entice, surprize, sell or transport or cause to be sold or transported out of this Province or otherwise dispose of any Friend Indian or Indians whatsoever or endeavour or attempt so to do without License from the Governour for the time being and all accessarys thereunto shall be fined & imprisoned at the discretion of the Governour & Council for the time being and that any person or persons whatsoever that shall inform again^t or cause such offender or offenders to be apprehended shall have such satisfaction therefor as the Governour and Council shall think fit.
