(4) County, in the County Leavy where such Town shall be laid out.

And in case the taker up of such Lott or Lotts resule and neglest to build upon such Lot or Lots within the time aforesaid by this Act appointed, that then it shall & may belawful for any other person or persons whatsoever to enter upon the said Lott or Lotts so as aforesaid not built upon, paying such Sum of Tobacco as shall be first leve and assessed upon such Lott to the Commissioners asoresaid, or such orher person as the Commissioners in each respective County or the major part of them shall nominate and appoint to receive the same, for the publick use and benesit of such Town wherein such Lotts shall lye, and be taken up the second time.

Provided allways that such second taker up or purchasor build and finish within one Year after such his Entry made, sirch House as in this Act is before limitted and appointed to be built by the Fiest Taker up, which House so built, shall give and settle as good Estate to all intents and purposes to such second takes up and builder as aforesaid his Heirs and Assigns as is in and by this Act before limitted and settled upon the fest taker up and builder, subject to the same Rents and Reservations in and by this Act before limitted and appointed.

And in case any the said Lots shall be neglected to be taken up in any the Ports or Towns aforesaid in any County of this Province for and during the term of seaven Years next after the publication of this Act, that then and in such case, the Owner or persons interested at the sirst in such Land shall after siich time expired, be possessed & interested in the said Lott or Lotts as in their sirst and sormer Estate, any thing in this A& contained to the contrary norwithstanding.

Be it surther Enacted by the authority advice & consent aforesaid, that from & after the first Day of January 1707 all Masters of Ships and Vessells Trading into this Province shall unlade and put on shoar all Goods and Merchandizes in such Ships and Vessells imported to be fold here by any Merchants, or Goods configned to their Factors at fuch Towns Ports and Places as are before sett down and appointed in this Act for unlading Goods and merchandizes and at no other place or places what foever, on pain of losing or forfeiting all such goods and merchandizes by them landed or put on ilioar at any other place or places whatfoever then as aforesaid, one third part thereof to her Majesty her Heirs and Successors for the support of the Government of this Province, one other third part to the use of the County where such goods shall be put on shoar for and towards the defraying the County charge, and the other third part to the Informer, or him or them rhat will inform or sue for the same, to be recovered in any Court of Record of this Province by Action of Debt Bill Plaint or Information, wherein no Essoyn Protection or Wager of Law to be allowed.

And be it further Enacted by the Authority aforesaid, by and with the Advice and Consent ascresaid, that from and after the first Day of January 1707, no Merchant, Factor or Mariner trading into this Province shall traffick, sell or barter away any goods, or commoditys imported or brought into this Province and not really and bona fide wholly owned by and upon the proper account and risque of the Inhabitants of this Province, but at some of the Towns Ports or plac's before in this Act appointed to be Ports or Towns, under the pain of forfeiting to her Majesty her Heirs and Successors all such goods and merchandizes sold or barter'd away at any other place or place within this Province or the full value thereof, to the uses aforesaid to be recovered as aforesaid, wherein no Essoyn Protection or Wager of Law to be allowed, any

Law, Statute, Usage or Custom to the csontrary notwithstanding.

And be it further Enacted by the Authority aforesaid, by and with the Advice and Consect aforesaid, that there shall be allowed to all debtors whatsoever owing any tobacco to any person or persons whatsoever or howsoever, such debtor bringing his tobacco to the Ports Towns or places aforesaid, and there paying the same to his Creditor or Creditors; or his or their Receivers, the Sum of Tenn pounds of Tobacco per cent' for every Hundred pounds of Tobacco fo brought to the places aforesaid and there paid as asoresaid, to be deducted out of such Debtors said Debt, or allowed of in barr or discount of any Action to be brought against any Debtor or Debtois by any Creditor or Creditors in any Court within this Province. And

Be it further Enacted by the Authority Advice & Consent aforesaid, that any person or persons that shall dwell and inhabit in any of the said Ports Towns or Places, such person or persons shall and may contract for, barter, buy and purchase any quantity or quantity's of goods or merchandizes whatfoever, any Law Statute or Usage to the contrary notwithstanding. Provided nevertheless, that such person or persons buying or contracting, or any ways purchasing, bartering or ingrosing such goods, wares or merchandizes, shall likewise sell or burter away the said goods and merchandizes its the same Town Poir or Place where they were bought, or in some other Port or Town
