Be it therefore Enasted by the Queens Most Excellent Majesty by and with the Advice and Confent of Her Majellys Governour Council and Allembly of this Province and the Authority of the fune, that from and after the first Day of Jane next enfung After the End of this prefent Settion of Atlembly the faid Hundred of Newport thali be divided and taken from the faid Parith called King & Queers Parith in St. Harys County and be added and united unto William and Mary Pari h in Charles County in which the same lyes, & shall from & after the time aforesaid by vertue of this Act be deem'd a findged reputed and taken as part and parcel of the faid William & Miry Parish and not as part or parcel of King & Queen's Pari h in St. Mires County & that the Inhabiteants thereof thall have & enjoy all Benefits & Priviledges eq 111 with any other the Inhabitants of the faid Parith, any Law Statute Ulage or Cultom to the contrary nonwith.tanding.

An All Incouraging the making Hemp and Flax within this Province.

HE Inhabitants of this Province being in a great measure incouraged by our Most Gracious Queens Royal Assent to an Act of carliament made in the Third and Fourth Years of Her faid Majestys Reign Intituled An Act for incouraging the Importation of Naval Stores from Her Majestys Planiations in America to make Flemp within this Prov nee, & this present Cene al Assembly being willing & desirous that the faid Incouragement should not prove inesse qual, but that so good and great an advantage to this Province should be furthered & promoted, for further incourage-

ment thereof do pray that it may be Enacted,

And Bo it Enacted by the Queens Most Excellent Majedy by and with the Advice and Confent of her Majedys novemour Council and Alfembly of this province & the Authority of the fame, That if any person or persons Living or inhabiting within the Province, shall hereafter make by him her or themselves, or by his her or their strwants or Workmen upon any the Lands or Plantations within this Province any quanrity or quantity's of Femp or Hax and cause the same to be Water Rotted beight and clean and made merchantable, and that fuch person or persons making such Hemp or Hax be in lebred to any perfon or perfons reliding or trading into this Province in any tum or fums of many or tabased that their fach person or persons to whom the same are or thall he due that he & are hereby obliged to take & receive of & from fuch his her or their debrer or debtors tendring in some Port or I own within this Province such Hemp or Flax Water Rotted bright clean and made merchantable, one fourth part of Such debt due from fach Debtor or Debtors that can and will tender and pay the fime after the Rate of fix pence per pound for Hemp and nine pence per pound for Flax and so proportionably for any greater or lesser quantity, and according to the same Rate in Tobacco at one panny per pound, and if any Creditor or Creditors shall refuse to accopt and take such quantity of Hemp or Flax at the Rates aforesaid when to them rencired towards farisfaction of his debt & shall after such tender bring any Action at Law against the Dehtor for the same, that then such Debtor pleading a tender of such Hemp er Flax and proving the same to Essect the Plaintif shall be Nonsuite & shall pay Costs to the Desendant.
