

Of Elk River aforesaid and Running with the said River... thereof, then East to the Exterior Bounds of this Province... of this Province to *Susquehanna* River, thence with the East... Bay of *Chesepack* to the first beginning, shall be and is by this... and made into a Parish to be called by the Name of *North Elk* Parish separated and divided as aforesaid from the Parish already made in the said County, and shall be and is hereby adjudged deemed and taken to be a separate and distinct Parish, and shall have hold and enjoy all priviledges and advantages that are held and enjoyed in other Parishes in this Province.

An Act to prohibit the Exportation of European Commodities out of this Province.

B E I T E N A C T E D by the Queens Most Excellent Majesty by & with the Advice and Consent of Her Majesty's Governour Council and Assembly of this Province and the Authority of the same, That no Goods or Commodities of the produce or manufacture of *Europe* now or at any time after the End of this Sessions of Assembly imported into this Province shall be exported or carried out of this Province by Land or Water to any other place whatsoever on pain of forfeiting to her Majesty her Heirs & Successors all such goods or commodities so exported or accounted to be exported out of this Province or the full value thereof, one half thereof to her Majesty her heirs & Successors for the support of the government of this Province, & the other half to the Informer or him or them that will inform or sue for the same, to be Recovered against such Exporter, by Action of Debt Bill Plaintiff or Information in any Court of Record within this Province, wherein no *Ellovn* Protection or Wager of Law to be allowed.

Provided allways, that this Act nor any thing therein contained shall extend or be construed or taken to extend to Goods, & Merchandizes imported into this Province which are *bona fide* consigned or belonging to any person or persons actually residing in the Colony of *Virginia* or Province of *Pennsylvania*, or Goods & Merchandizes imported in order to be shipped off for the Coast of *Guinea*, this Act to endure for three Years, and from thence to the End of the next Sessions of Assembly which shall happen next after the End of the said three Years.

An Act declaring several Acts of Parliament made in the Kingdom of England to be in Force within this Province.

B E I T E N A C T E D by the Queens Most Excellent Majesty by and with the Advic & Consent of her Majesty's Governour Council and Assembly of this Province and the Authority of the same, that the Act of Parliament made at the Parliament begun and held at *Westminster* the Nineteenth Day of *March* in the First Year of the Reign of our late Sovereign Lord King *James* the First Entituled *An Act to Restrain all Persons from Marryage until their former Wives and former Husbands be dead*, and the several penal Acts of Parliament of *England* mentioned in the Act of Parliament made at the Parliament held at *Westminster* in the First Year of the Reign of our late Sovereign Lord and Lady King *William & Queen Mary* Entituled *An Act for Exempting their Majestys Protestant Subjects dissenting from the Church of England from the penaltys of certain Laws*, together with the said last mentioned Act of Parliament Exempting their Majesty's Protestant Subjects dissenting from the Church of *England* from the penaltys of the said Laws, and every Article Clause Matter and Thing in the said Acts contained shall be and are in full Force to all Intents and purposes within this Province.

An Act empowering a Committee to lay assess and apportion the publick Levy of this Province for this present Tear one thousand seven hundred and six.

W H E R E A S this present General Assembly have for the defraying the publick Charge of this Province to the Eighteenth Day of *April* One Thousand Seven Hundred and Six Raised a certain Sum of Tobacco and Money amounting to the Sum of two hundred sixty one thousand seven hundred & twenty six pounds of tobacco, and the Sum of One Hundred Ninety Eight Pounds Eleven Shillings and four pence currant Money of this Province as by the Journal of the Committee of Accounts appears.

But by reason more publick charges may arise and grow due before the Tenth Day of *October* next which is the usual and accustomed time of payment, at which time a great number of them & the remoteness of their habitations from the place appointed would be very chargeable and troublesome to the whole Province in general.
