

Be it Enacted by the Queens Most Excellent Majesty by and with the Advice and Consent of her Majesty's Governour Council and Assembly of this Province and the Authority of the said Burgesses or Delegate for each respective County and one for the City of *St. Marys* be & are hereby authorized & appointed a Committee to joyn with some of her Majesty's honourable Council to lay & equally assess the said publick Levy of this Province (that is to say) of her Majesty's honourable Council the Honourable *Thomas Tench* Esquire, *Robert Smith* Esquire, Colonel *John Hammond* and Lieutenant Colonel *William Holland*.

And of the House of Delegates for *St. Marys* City Mr. *George Muschamp*, for *St. Marys* County Mr. *William Watis*, *Thomas Smyth* Esq<sup>r</sup> for *Kent* County, for *Ann-Arundel* County Mr. *Charles Greenberry*, for *Calvert* County Mr. *John Leach*, for *Charles* County Colo<sup>r</sup> *John Contee*, for *Baltimore* County Mr. *James Maxwell*, for *Somerset* County Mr. *John Ma-Clester*, for *Talbot* County Mr. *Nicholas Lowe*, for *Cecil* County Mr. *Edward Biay*, for *Dorchester* County Mr. *Hugh Ecclestone*, & for *Prince Georges* County Mr. *Thomas Greenfield* or the major part of them shall be and appear at the Town & Port of *Annapolis* the first Tuesday of *October* next then and there to lay and assess the said publick Levy already raised, and also to allow levy and assess what further charges may accrue which to them shall justly appear to be due from the publick not exceeding two Hundred Thousand pounds of tobacco, and one Thousand Pounds currant money of this Province more than what is already raised, and to apportion order and pay the same to the severall persons to whom the same shall be due, and a fair Journal of all their proceedings deliver to the Clerk of the Assembly for satisfaction of all persons therewith concerned.

But if it shall happen that his Excellency shall please to convene an Assembly before the first Tuesday of *October* aforesaid, then this present Act and all and every clause therein contained shall be void & of no Effect.

An Act to make null & void a certain Deed or Conveyance made by *Thomas Edmondson* to *William Edmondson* & remaining upon Record in *Dorchester* County Court.

An Act for Naturalization of *John Baptyft Tyler* of *Prince Georges* County Planter.

An Act for vesting & settling certain Lands in *John Whittington* and his Heirs late the Estate and Inheritance of a certain *Daniel Toas* for and towards satisfaction & payment of a debt due from the said *Toas* & paid by the said *Whittington*.

An Act to empower Trustees to sell the Freehold and Demesne Land of *Abraham Nailor* late of *Ann-Arundel* County deceased, and apply the Money to the uses mentioned in his last Will and Testament.

An Act declaring an Act Entituled An Act for suspending the prosecution of any Priests of the Communion of the Church of *Rome* incurring the penaltys of an Act of Assembly Entituled an Act for preventing the Growth of Popcry by Exercising their Function in a private Family of the Roman Communion but in no other case whatsoever to be in Force for twelve Months, or her Majesty's Pleasure known.

An Act declaring an Act Entituled an Act ascertaining the Bounds of Land to be in Force until the End of the next Sessions of Assembly.
