Parish which lies to the Northward and Westward of the before Lines, so far as St. Stephen's Parish extended to Elk River, and then by Elk River to Town-Point aforesaid; shall be taken from St. Stephen's Parish aforesaid, and be erected into a new Parish, and called by the Name of Au-a Part or Parcel of St. Stephen's Parish aforesaid, &c. (2.) The Inhabitants of Augustine Parish to enjoy all Benefits, Privileges, &c. in every respect, equal with any Inhabitants of any other Parish in this Province; with Power to elect Vestry-men, &c. (3.) The Chapel built on Bo-hemia Manor, to be reputed, deemed, &c. as the Parish Church of Augustine Parish. (4.) The Rev Mr. Hugh Jones to continue Incumbent of both Parishes during his Life, &c.

An ACT to prevent the Cutting up Tobacco Plants, Destroying of Tobacco and Tobacco-houses; and for ascertaining the Punishment of Criminals Guilty of the said Offences. Lib. B.L.C. fol. 286.

HEREAS Tobacco is the Staple of this Province, and that thereon Preamble, depends the Livelihood of many of the Inhabitants, as well as the most cosiderable Branch of Trade; and that it is as requisite that the Property of the People should be as well secured in the Fields, or open Houses, as in their Dwelling-houses: It is therefore prayed that it may be Enacted;

II. And he it therefore Enacted, by the Right Honourable the Lord Proprie- Penalty on tary, by and with the Advice and Consent of his Lordship's Governor, and the Persons cut-Upper and Lower Houses of Assembly, and the Authority of the same, That any stroying To-Person or Persons, who shall, after the End of this present Session of Assembacco, or him out or destroy of cause to be cut up or destroyed any Tobacco Diagram Tobacco bly, cut or destroy, or cause to be cut up or destroyed, any Tobacco Plants Plants; or belonging to any other Person or Persons, or by Threats, Menaces, or other exciting or sinister Means, shall cause or excite any Person or Persons to cut up or destroy there to do so. any Tobacco or Tobacco Plants, belonging to any other Person or Persons, and shall be thereof convict by due course of Law, shall forfeit and pay unto the Party grieved, One Hundred Pounds Sterling, and suffer Six Months Im-Fine and Imprisonment, without Bail or Mainprize; and shall also remain in Prison, as prisonment, in Execution, until the said Sum be satisfied, in case the Offender be of sufficient Ability to pay the same; and if the Offender shall not be of sufficient Ability, then, and in every such case, the Offender shall remain and continue in Prison for the Space of One whole Year, without Bail or Mainprize. 10ro: The Party vided also, That the Party grieved, shall and may have and maintain his or grieved shall her Action of Trespass, or other proper Action at Law, for Recovery of Da-have Action of Trespass, mages against the Offender; any thing herein contained to the contrary not- &c. withstanding.

III. And be it further Enaited, That any Person or Persons, who shall Punishment after the End of this Session of Assembly, wilfully Burn any Tobacco be- of Persons longing to any other Person, whether Hanging, or in Bulk, or Packed, or burning To. any Tobacco-house or Houses, having therein any Tobacco Hanging, or in bacco, or Bulk, or Packed, and be thereof convicted by due course of Law, and every houses. Aider and Abettor of such Offender, shall suffer Death as a Felon, without Death. Benefit of Clergy.

IV. This Act to continue Three Years, and to the End of the next Session Continuance, of Assembly, which shall happen after the End of the said Three Years.
