

set up, made, packed and filled, according to the Directions of this Act, **Be it Enacted, by the Authority aforesaid,** That whatsoever Person or Persons, shall wittingly or knowingly make, or set up, or cause to be made and set up, after the first Day of *October*, which shall be in the Year of our Lord One Thousand Seven Hundred and Forty-six, any Barrel or Barrels for Pork, Beef, Pitch, Tar, or Turpentine, of less Size, Gauge, or Dimensions, than is directed by this Act, all and every such Person or Persons, shall, for every such Barrel, forfeit and pay the Sum of Two Shillings and Six-pence Current Money, to be recovered and applied, according to the Directions of this Act herein after mentioned.

Penalty for making or setting up Barrels of less Size, 2/6 per Barrel.

IV. **And be it further Enacted, by the Authority aforesaid,** That whatsoever Person or Persons, from and after the said First Day of *October*, shall pack Pork or Beef for Sale, in any Barrel or Barrels made and set up contrary to this Act, in Size, Gauge, and Dimensions, or shall in any Barrel or Barrels, pack less Pork or Beef than this Act requires, *That is to say,* Sufficient to make each Barrel hold out, at Sale or Exportation, the Quantity directed by this Act to be the nett Quantity and Contents of a Barrel of Pork, or Barrel of Beef, all and every such Person or Persons, shall, for every such Barrel, forfeit and pay the Sum of Ten Shillings Current Money.

Penalty for packing Pork or Beef for Sale, contrary to this Act,

10 s. per Barrel.

V. **And be it further Enacted, by the Authority aforesaid,** That whatsoever Person or Persons, from and after the First Day of *October*, which shall be in the Year of our Lord One Thousand Seven Hundred and Forty-six, shall barter away, bargain for, or sell, or expose, or offer to Sale, in any way, within this Province, any Pork or Beef, in any Barrel or Barrels made or set up contrary to this Act, in Size, Gauge, and Dimensions, or shall barter away, bargain, sell, or expose, or offer to Sale, in any way whatsoever as aforesaid, any Barrel or Barrels of Pork, of less nett Contents in Pork, or any Barrel or Barrels of Beef, of less nett Contents in Beef, than this Act directs, all and every such Person or Persons, shall, for every such Barrel, forfeit and pay the Sum of Ten Shillings Current Money.

The like Penalty for selling, bartering, &c. Pork or Beef packed contrary hereto.

VI. **And be it further Enacted, by the Authority, Advice and Consent aforesaid,** That whatever Person or Persons, from and after the said First Day of *October*, shall barter away, bargain, or sell, or expose, or offer to Sale, in any way whatsoever, within this Province, any Tar, Turpentine, or Pitch, in any Barrel or Barrels, made and set up contrary to this Act, in Size, Gauge, and Dimensions, or shall barter away, bargain, or sell, or expose to, or offer to Sale, in any way whatsoever as aforesaid, any Barrel or Barrels of Pitch, filled up with other than good, true-made, merchantable Pitch, or any Barrel or Barrels of Tar or Turpentine, filled up with other than good merchantable Tar or Turpentine, shall, for every such Barrel of Pitch, not qualified according to the Direction of this Act, forfeit and pay the Sum of Five Shillings Current Money; and for every such Barrel of Tar or Turpentine, the Sum of Two Shillings and Six-pence Current Money.

Penalty for bartering, selling, &c. Tar, Turpentine or Pitch, contrary to this Act, viz.

Pitch, per Barrel, 5 s.

Tar or Turpentine, per Barrel, 2 s. 6 d.

VII. **And whereas** it often happens that Beef, Pork, Pitch, Tar, and Turpentine, are imported into this Province in Barrels, from other neighbouring Parts; For Prevention of Frauds and Abuses therein; **Be it Enacted, by the Authority aforesaid,** That whatsoever Person or Persons, from and after the said First Day of *October*, shall import or bring into this Province, by Land or Water, any Pork, Beef, Tar, Turpentine, or Pitch, in Barrel or Barrels, of less Size, Gauge, and Dimensions, than this Act directs; or any Barrel or Barrels of Pork of less nett Contents in Pork; or any Barrel or Barrels of Beef of less nett Contents in Beef, than this Act directs; or any Barrel or Barrels of Tar or Turpentine, filled up with other than good merchantable Tar, or Turpentine; or any Barrel or Barrels of Pitch, filled with other than good, true-made, merchantable Pitch; and shall within this Province, bargain away, barter

Persons importing the same Commodities in Barrels, Contents, or Quality contrary to the Directions of this Act, are liable to the same Penalties.
