set up, made, packed and filled, according to the Directions of this Act, BechAP. it Enacted, by the Authority aforesaid, That whatsoever Person or Persons, Av. shall wittingly or knowingly make, or set up, or cause to be made and set up, Penalty for making or after the first Day of October, which shall be in the Year of our Lord One setting up Thousand Seven Hundred and Forty-six, any Barrel or Barrels for Pork, Beef, Barrels of less Pitch. Tar. or Turpentine. of less Size. Gauge. or Dimensions, then is displayed.
