3 FREDERICK Lord BALTIMORE.

At a Session of ASSEMBLY begun and held at the City of Annapolis, the 2d Day of October, and ended the 17th Day of November, in the 3d Year of the Dominion of the Right Honourable FREDERICK, absolute Lord and Proprietary of the Provinces of Maryland and Avalon, Lord Baron of Baltimore, &c. Annoq; Domini 1753: The following Laws were Enacted.
