and in Words at length; and whenever any Person or Persons interested in CHAP. them, or to whom the same shall be charged, shall desire a Copy of such Account, the several Officers shall, and are hereby required to give such Person Accounts of sannlying therefore in as thort a Time as may be convenient. so applying therefore, in as short a Time as may be convenient, an Account and Copies of such Charge in Words at length. And that all Under-Clerks and Depu-thereof, to be ties, writing in any the Offices aforesaid, or doing Service in them, shall by words at the Time aforesaid, or before they enter into any of the Services aforesaid, length. before some Provincial or County Magistrate (who is hereby authorized and Underrequired to administer the same), take the following Oath, under the Penalty be sworn. of Five Thousand Pounds of Tobacco for every such Resulal or Neglect, to Penalty for be recovered in any Court of Record within this Province, by Action of Debt, refusing to Delt, fivear, Bill, Plaint, or Information, wherein no Essoin, Protection, or Wager of Law, shall be allowed, nor more than one Imparlance; the one Half to the Informer, or him or them that will sue for the same, and the other Half to the Use of the County where such Neglect or Resusal shall happen, towards defraying the Charge of carrying this Act into Execution, viz. " You A. B. The Oath. " do Swear, that you will not, for Lucre or Malice, delay any Person or Persons " applying to you for any Business belonging to the Office you officiate in; and that " you will not, directly or indirectly, ask, demand, take, or receive from, or charge " to, any such Person or Persons, to your own Use (except your Salary from your " Principal), any Fee or Reward what soever, for any Service you shall do as Clerk " of the said Office: And also, that in making out the Office Fees, you will not " wittingly or willingly charge other or higher Fees, than limited by the Act enti-" tled, An Act for amending the Staple of Tobacco, for preventing Frauds in " his Majesty's Customs, and for the Limitation of Officers Fees." Which faid Oaths beforementioned, shall be severally returned by the Magistrate be-Oath to be fore whom the same shall be taken, to the Provincial or County Offices, as recorded. the Case shall require, and be there entered on Record. And that all and Table of Fees every Person or Persons, claiming Right to any Fee or Fees, allowed by this to be set up. Act, shall be obliged to set up and affix in the most public Place of his Office, a Table of Fees, to the Intent that all Persons concerned may have Recourse to the same.

CXII. And be it further Enasted, That no Officer or Officers herein be- Timeofsendforementioned, under the Penalty aforesaid, to be recovered as aforesaid, shall ing out Fees make or fend out their Fees on Execution but once in every Year, and that annually. between the First Day of December, and the Tenth Day of January yearly, during the Continuance of this Act. And that the Party or Parties charged, Accounts to their Persons, Goods, or Chattels, shall not be executed for any of the afore-be delivered faid Fees, unless their Accounts be delivered them at an hospital before the last said Fees, unless their Accounts be delivered them at or before the last Day of February. of February, in any Year they shall be demanded.

CXIII. And be it further Enasted, That wherever any Deputy-Surveyor Deputy-Surreturns a Certificate or Certificates, for the Examination of the Examiner-veyors mak-General, and that the same shall be found erroneous, that in such Case, the ing erroneous Party for whose Use survey is made, shall not be burthened with double pay the extra Fees, either by the Examiner-General or Deputy-Surveyor; but that the Fees. several Deputy-Surveyors shall pay the Examiner-General for any extraordinary Trouble they give him in re-examining, such Fees as by this Act is allowed to the Examiner-General.

CXIV.
