- Herman, Ephraim Augustine, *vested in a Fee Simple Estate of Little Bohemia, and enabled to cut off the Entail; 1724, ch. 4.*
- Herman, Catherine, *Widow, enabled to sell Land in Annapolis, according to the Contract of her deceased Husband, 1697, ch. 4.*
- Hickman, William. *Lands in Calvert County vested in him, which were formerly purchased by his Father from Thomas Hinton, 1711, ch. 12.*
- Hicks, Thomas. See *Smithson Thomas*.
- Hill, Moses. See *Hammond William*.
- Hinton, Thomas. See *Hickman William*.
- Holdsworth, Samuel. *The Title of a Parcel of Land in Calvert County, confirmed to him and his Heirs, against Edward Hufbands and his Heirs for ever, 1681, ch. 17.*
- Holland, Jacob. See *Holland's-Choice*.
- Holland, William, (Col.) *Confirmation of Lands to him, Richard Harrison, and Samuel Chew, 1709, ch. 4; and 1711, ch. 7.*
- Holland's Choice. *The Entail cut off, and Jacob Holland enabled to sell the same, and entail other Lands in Lieu thereof, 1749, ch. 14.*
- Hollingsworth, Thomas. See *Wells Zorobabel*.
- Hollyday, James. *Enabled to draw Bills for a certain Balance of Sterling Duties, received by his Father James Hollyday, Esq; late Treasurer of the Eastern Shore, and by him remitted to William Hunt, Merchant in London, 1762, ch. 15. Enabled to pay Money to the Visitors of Worcester County School, 1763, ch. 16.*
- Hollyday, Leonard. *Certain Lands vested in his Female Heirs, 1756, ch. 17.*
- Hollyday, Sarah, *Widow. Enabled to pay Money, 1748, ch. 23.*
- Hood, Caspar. See *Howel Thomas*.
- Hope. *A Tract so called. See Goodridge's Choice.*
- Howard, Benjamin. *Enabled to sell Lands in Anne-Arundel County, and to entail other Lands in Baltimore County, 1718, ch. 12. The Survey of Howard's Purchase made good to him, 1720, ch. 7. See Roper's Neck.*
- Howard, John Greenriff. *Impowered to dock the Entail of Part of Harborough, and to entail other Lands in Lieu thereof, 1755, ch. 18.*
- Howard's Purchase. See *Howard Benjamin*.
- Howel, John. See *Bennet Richard*.
- Howel, Thomas. *A Mortgage from him to Edward Beck, Attorney in Fact for Caspar Hood, confirmed, 1735, ch. 21.*
- Howerton's Range. See *Duvall Benjamin*.
- Huddleston's Right. See *Stirling James*.
- Humphries, Thomas, Esq; See *Gresham John*.
- Hurd, John. *A Deed to him from Bartholomew Atkison, and Sibera his Wife, made valid, 1727, ch. 15.*
- Husbands, Edward. *Punished for Menacing and Cursing the Assembly, 1678, ch. 18. See Holdsworth Samuel.*
- Husbands, William. *Defects in a Deed to him, of Stillington and Chance, in Cæcil County, from Edward Warner, supplied, 1731, ch. 16.*
- Hutcheson, William. *Declaration of what Estate Gabriel Parker and Anne his Wife, John Abbington and Mary his Wife, William Hutcheson, and William Pile, and Elizabeth his Wife, have in the Lands devised by him to them, 1724, ch. 5.*
- Hutchinson, William. *A defective Entry in the Records of Prince George's County, of a Deed to him from John Wheeler, aided, 1755, ch. 4.*
- Hyde, John, of London, *Merchant. Certain Lands confirmed to him, 1708, ch. 6. See Stirling Thomas.*
- Hynson, John. See *Bryan Matthew*.

- JACKSON, Thomas. See *Read Henry Wallace*.
- ST. JAMES'S Parish, in Anne-Arundel County. *Certain Lands vested in the Vestry thereof, given by James Rigby and Elizabeth his Wife, both deceased, 1701, ch. 5. The Rector and Vestry enabled to lease certain Church Lands, 1744, ch. 21. A new Church to be built, 1762, ch. 28.*
- JANSEN-TOWN, in Anne-Arundel County, *Erected, 1733, ch. 3.*
- Jarboe, John, (Lieut. Col.) *His nuncupative Will confirmed, 1676, ch. 10.*
- Johns, Isaac. See *Adair Robert*.
- ST. JOHN'S Parish, in Baltimore County. *Stoakley Manor, alias Stoak Flemmon, settled on the Rector and his Successors, for ever, 1719, ch. 6. A Chapel of Ease to be built in the Fork of Gunpowder River, 1752, ch. 15; and 1753, ch. 32. See Eaton Jeremiah.*
- ST. JOHN'S Parish, in Prince George's County, *divided, and Prince George's Parish erected thereout, 1726, ch. 6. A Chapel of Ease erected on the Land given by William Scott, 1744, ch. 12. The Vestry enabled to purchase Three Acres of Land, and to build a Chapel of Ease thereon, 1744, ch. 26; and 1748, ch. 16. A Parochial Assessment for enlarging the Church, 1763, ch. 27.*
- In the Acts of 1744, ch. 12 and 26; and 1748, ch. 16, there is a Misnomer, the Parish being therein called King George's Parish; which happened (as I am informed,) thro' the Whim of the then Incumbent, who would needs have the Elder Parish, as Parent of the Younger, to be called K. George's Parish, though without any legal Authority.*
- ST. JOHN'S Parish, in Queen Anne's and Talbot Counties, *erected out of St. Paul's, 1748, ch. 13.*
- Johnson, Robert. *A Lot in ANNAPOLIS settled on him, 1719, ch. 5. The same Lot, after his Decease, settled on Robert Gordon, 1723, ch. 26. And lastly, on Horatio Samuel Middleton, and his Heirs, 1753, ch. 25.*
- Johnson, Sufannah. *Confirmation of Lands in Anne-Arundel County, to her, 1716, ch. 15.*
- Johnson, Thomas, Esq; See *Hancox Edward*.
- JONAS-TOWN, in Baltimore County, *Erected, 1732, ch. 14. United to Baltimore-Town, 1745, ch. 9.*
- Jones's Fancy. See *Matthews Hugh*.
- Jones, John. See *Bennet Richard*.
- Jones, Thomas. *Confirmation of a Sale of Land to him from Joseph Bridger, Esq; 1716, ch. 18.*
- JOPPA, *Erected into a Town, 1724, ch. 16; and 1737, ch. 11.*
- Jordain, John. *Enabled to sell Billingsley's Point, 1724, ch. 3. A Deed to him from Thomas Larkin, deceased, to be recorded, 1756, ch. 18.*
- Joseph, William. *Confirmation of a Letter of Attorney to him, from his Father William Joseph, Esq; for the Sale of Lands, 1705, ch. 3.*
- Ivy, Anthony, and Anne his Wife, (Daughter and Heiress at Law to Robert Smith, Esq;) *A Mortgage of Land confirmed to them, 1713, ch. 7. A Conveyance of Land from them to Richard Moore and Edith his Wife, confirmed, 1716, ch. 4. The like from them to John Alla, 1716, ch. 9. The like from them to Thomas and John Davies, 1716, ch. 10.*

- KING AND QUEEN Parish, in St. Mary's County. *A new Church to be built, and Newport Church to be repaired, 1735, ch. 9; and 1736, ch. 13. Its Bounds ascertained, 1748, ch. 4. See also, Ibid. ch. 9. A Chapel of Ease to be erected, 1750, ch. 21. Chaptico Church to be repaired, 1754, ch. 6.*
- KING GEORGE'S Parish. See *St. John's Parish in Prince George's County*.
