- Patuxent River. Acts for making the main Branch navigable, above Queen-Anne Town, 1733, ch. 9; and 1736, ch. 15. A Breach made thereby, across the main Road in Queen-Anne Town, to be stopped, 1750, ch. 15.
- ST. PAUL'S Parish, in Baltimore County, divided; and Part thereof, lying in Anne-Arundel County, united to Westminster Parish, 1722, ch. 3. The remaining Part thereof, lying in Anne-Arundel County, annexed to Queen Caroline Parish, 1728, ch. 15. Acts relating to the Parish Church, 1727, ch. 10; 1730, ch. 9; 1731, ch. 11; and 1749, ch. 6. The Parish again divided, and St. Thomas's Parish erected thereout, 1742, ch. 15. A Chapel of Ease to be built at a Place known by the Name of T L, 1762, ch. 25.
- ST. PAUL'S Parish, in Kent County, and Shrewsbury Parish. An Act for their better Division, 1698, ch. 5.
- ST. PAUL'S Parish, in Prince George's County, divided, and Queen Anne's Parish erected thereout, 1704, ch. 96. A new Church and Chapel of Ease to be built, 1732, ch. 29. The Grave-Yards to be railed in, and the Church and Chapel to be repaired, 1753, ch. 18.
- ST. PAUL'S Parish, in Queen Anne's and Talbot Counties, divided; and St. Luke's Parish erected thereout, 1728, ch. 19. Again divided, and St. John's Parish erected thereout, 1748, ch. 13.
- Pemberton, Deborah. See Grundy Robert.
- Philips, James and Anthony. Their Devisees relieved, 1724, ch. 15. The same repealed, 1732, ch. 16.
- Pile, William, and Elizabeth his Wife. A Defect in the Certificate of Acknowledgment, in a Conveyance between them and Thomas Marshall, of Part of a Tract called Carrick, aided, 1735, ch. 13. See Hutchinson William.
- Plater, George, Esq; Onorio Razolini enabled to convey Lands to him, in Right of Elizabeth Calvert, an Infant, 1747, ch. 20.
- Plummer, Thomas. Deed from him to Francis Swanson, confirmed, 1720, ch. 16.
- Plymouth. A Tract so called. See Speake John.
- Pollard, Tobias and John. Acts for their Relief, 1709, ch. 8; and 1711, ch. 14.
- PORT-TOBACCO Parish. A new Church to be built, 1751, ch. 12; and 1753, ch. 12. A Chapel of Ease to be built at Ivy-Spring, 1754, ch. 7. A Parochial Tax for the Support of an Organist, 1758, ch. 16; and 1763, ch. 31. Some Vestry Proceedings, aided, 1760, ch. 6. An Addition to be made to the Chapel of Ease, 1762, ch. 22.
- Presbury, James. See Marshall William.
- PRINCE-GEORGE'S Parish erected out of St. John's in Prince George's County, 1726, ch. 6. Divided, and All-Saints Parish erected thereout, 1742, ch. 18. A Chapel already built therein, made a Chapel of Ease, 1744, ch. 2.
- PRINCESS-ANNE Town, in Somerset County. Acts relating thereto, 1733, ch. 13; 1745, ch. 5; 1747, ch. 5; 1751, ch. 16; and 1753, ch. 33.
- Proctor, Robert. Confirmation of a Deed of Settlement made by him to his then Wife, now Rachel Freeborn, 1724, ch. 9.

- QUEEN-ANNE'S Parish, in Prince-George's County, erected out of St. Paul's, 1704, ch. 96. A Parochial Assessment for repairing the Chapel, built and given to the Parish by the Rev. Jacob Henderson and his Wife, and the same made a Chapel of Ease, 1741, ch. 7. The Church and Chapel to be repaired, 1744, ch. 11. The Chapel Yard to be paved in, &c. 1750, ch. 9.
- QUEEN-CAROLINE Parish erected out of Part of St. Paul's, All-Hallows, and St. Anne's Parishes, in Anne-Arundel County, 1728, ch. 15. The Entail of

- Two Acres, on which the Church stands, cut off, 1737, ch. 12. A Chapel of Ease to be built, 1750, ch. 23.

- Ritteau, Sufannah, Widow of Robert Ritteau, impowered to sell a House and Lands, for Payment of her deceased Husband's Debts, 1757, ch. 32.

- Roberts, Robert. Impowered to sell Part of a Tract of Land, called New-Munster, late the Land of John Toas, 1711, ch. 13.
- Robins, George, Gent. An Act for his Relief, 1723, ch. 9.

- Rogers, Nicholas. See Speedy Payment.
- Rogers, William. See Tennison John.
- Roper's Neck. The Entail cut off, and Benjamin Howard enabled to convey the same, in Exchange for other Lands, 1741, ch. 3.

- Ryder, John, (Col.) Defects in a Deed to him from William Green, of Marsh-Island, Green's Privilege, and Green's Adventure, in Dorchester County, supplied, 1731, ch. 14.

- SALISBURY-TOWN, in Somerset County, erected, 1732, ch. 15.
- Scarborough, Henry. See Perry Richard.
- Scott, William, and Sarah his Wife. A Deed to them from James Gold and Elizabeth his Wife, made valid, and to be recorded, 1731, ch. 7. See St. John's Parish in Prince-George's County.
- Stutt's Level. See Douglass Archibald.
- Sewell, Charles. An Act for his Relief, &c. 1741, ch. 12.
- Sherrard, Lucy. See Mann Edward.
- Sherwood, Francis. An Estate in Fee Simple confirmed to him, of Lands devised by his Father, 1712, ch. 13.
- SHREWSBURY Parish, in Kent County. An Act for the better Division of it and St. Paul's, 1698, ch. 5. A Chapel therein to be finished, 1748, ch. 2.
- Smith, Edward. A Lot in Annapolis granted to him for a Sawyer's Yard, 1720, ch. 21.
- Smith, Henry, (Capt.) Part of his Lands to be sold for Payment of his Debts, 1704, ch. 13.
- Smith, John. A Mistake in a Deed to him from the Devisees of Philip Lynes, Esq; regulated, 1713, ch. 5.
- Smith, Robert, Esq; A Lease between him and Matthew Mason, confirmed, 1709, ch. 1. His surviving Executor
