shall be had and obtained; in which actions of debt, it shall be sufficient for the CHAP. plaintiff to allege, that the defendant or defendants are indebted to the plaintiff the fums of money or tobacco by this act directed and inflicted, whereby the plaintiff's. action accrued to him, according to the form of this act of affembly, without fetting forth the special matter; provided a short note; expressing the cause of action, be lodged in the office at the time of issuing the writ.

XXIII. And he it further enacted, That all sheriffs, bailiffs, constables, and Officers to be all other officers and ministers of justice, shall be aiding and affishing to the said aiding and affishing to the trustees for the poor in each of the said counties, and to all such officers as shall trustees, &c. be employed by them, as by this act is directed, in the execution and performance of the faid fervice.

XXIV. And he it further enacted, That if any person or persons shall, at any Persons sued time or times, be sued or prosecuted for any matter or thing by him or them done general issue, and executed in pursuance and execution of this act, or of any matter or thing in &c. this act contained, such person or persons shall and may plead the general issue, and give this act and the special matter in evidence for his or their defence; and if, upon trial, a verdict shall pass for the defendant or defendants, or if the plaintiff or plaintiffs shall become nonsuited, or discontinue his or their suit, then such defendant or defendants shall have and recover treble costs to him or them awarded against such plaintiff or plaintiffs; and if the plaintiff or plaintiffs is or are unable to satisfy the same, then it shall be paid and satisfied by the attorney who brought fuch suit, unless the plaintiff or plaintiffs shall give security for the costs, to be approved of by the court in which such suit is brought.

XXV. And, to prevent individuals being unreasonably burthened with the execution of this act, as trustees for the poor, Be it enacted, That at the time of the A trustee to meeting of the said trustees for the poor, in the first week of May yearly, the said be elected trustees, or the major part of them, in the counties aforesaid, respectively, shall and yearly, &c. may elect and choose one of the best inhabitants of the same county to be a trustee for the poor of that county, in the stead of the first named or eldest of the said trustees of the same county, which said first named or eldest trustee, shall be and is, by virtue hereof, thencefrom discharged from his office.
