C H A P. IV.

An ACT continuing an act, entitled, An act to oblige infected ships and other vessels coming into this province to perform quarantine.

C H A P. V.

An ACT continuing an act, entitled, An act to increase the allowance of jurors attending the provincial and county courts, and for other purposes therein mentioned.

C H A P. VI.

An ACT continuing an act, entitled, A supplementary act to the act, entitled, An act for ascertaining what damages shall be allowed upon protested bills of exchange.

C H A P. VII.

An ACT continuing an act, entitled, An act for amending the staple of tobacco, for preventing frauds in his majesty's customs, and for the limitation of officers fees, and the supplementary act thereto:

C H A P. VIII.

An ACT for applying a sum of money, in bills of credit, to the use therein mentioned. PR:

C H A P. IX.

An ACT to secure to Thomas Smyth, the right in a lot of land in Chester-town. PR.

C H A P. X

An ACT for appointing places for holding the next election of delegates for Baltimore county.

Viz. at Baltimore-town for four successive days (if necessary); and after an interval of one day, for four days (if necessary) at Bush-town. The sheriff is first to make proclamation, and, in the usual manner, to give not less than ten days public notice of the days and places. The election, however, is not to be held longer than four days at either place. Baltimore county having been divided since the passage of this act, and the constitution giving directions as to elections in all counties, this act is not in force.

C H A P. XI.

An ACT for the relief of Mary Hindman, of Talbot county. PR.

C H A P. XII

An ACT to enable the justices of Queen-Anne's county court, for the time being, to levy on the taxable inhabitants of St. Luke's parish, in the said county, a quantity of tobacco for building a chapel in the said parish.

The justices are directed to meet, between the 20th of December and 12th of January following, to assert affess on this parish 30,000lb. of tobacco; and in November 1770, they are to assess 30,000lb. more; the whole, as well as the money and tobacco already in their hands, is to be applied, by the vestrymen and wardens, to building, at the place where the old chapel stands, a new chapel, which is to bear the name of St. Andrew.

C H A P. XIII.

A Supplementary ACT to the act, entitled, An act for laying out a-new, and fettling and afcertaining the future bounds and limits of, St. Luke's, Christ Church, and St. John's parishes, in Queen-Anne's county, and of St. Paul's parish, lying partly in Queen-Anne's and partly in Talbot county.

This act is repealed by the act of September, 1770, ch. 9, and as nothing was done under it, and as the repealing act has, in its flead, made provisions, there is no necessity for reciting the substance of it.

C H A P. XIV.

An ACT for emitting bills of credit, and other purposes therein mentioned.

Bills of credit, to the amount of 318,000 dollars, are to be struck, under the direction of two commissioners, whom the governor shall appoint. These persons are to take an oath of office, the usual oaths to government, and the test, and to give bond for the faithful discharge of their duty. They are to be styled commissioners for emitting bills of credit," by that name to have succession, and to sue or be sued in all cases relative to their trust. For their services they are to be allowed each, clear of the necessary expences of their office, 400 dollars for the first year, and 320 for every year after. They are to attend at their offices on stated days and hours, and to be assisted by a clerk of their own appointment, who is to take the same oaths, to give bond for his sidelity, and to be allowed for his services 300 dollars the first year, and 250 for each succeeding year.

The commissioners are to attend the press. Particular directions are given to them for preventing fraud or misconduct in the printer or his servants, who are likewise to be laid under the obligation of an

oath.
