## H A P. XXI.

An ACT for the building of a parish church, in Christ-Church parish, in Calvert county.

Any three justices may meet at Prince-Frederick-town, between the 20th of December and the 20th of January next, and assess on the said parish one third part of 160,000lb. of tobacco; the other two thirds shall be assessed in 1770 and 1771, and the whole is to be laid out by the vestrymen and wardens in building a new church, on the ground where the old church stands. Provided and declared nevertheless, That no other mode of evidence which is legal or now used in this province, shall be hereby excluded.
