C H A P.

An ACT to establish a market in Frederick-town, in Frederick county, and for the regulation of the said market.

Preamble.

THEREAS it has been represented to this general assembly, That the inhabitants of the faid town had built and erected a large and convenient building, calculated for a market-house and other public uses, which, if put under a proper regulation, might be rendered very useful to them and the inhabitants of the said county; and it is prayed, that an act of assembly may be passed, for holding and regulating the market of the said market-house, and for the appointment of a clerk of the said market, by the justices of Frederick county court.

Market days appointed,

II. Be it therefore enacted, by the right honourable the lord proprietary, by and with the advice and confent of his lordship's governor, and the upper and lower houses of assembly, and the authority of the same; That from and after the twentieth day of this present month of November, two days in every week, to wit, Wednesday and Saturday, shall be held as market days, at the market-house, in the town of Fredérick aforesaid; and that all victuals and provisions whatsoever, brought to the said town for sale (except fish and oysters, all kinds of grain, flour and bread, butter in firkins, or other vessels, exceeding twenty pounds net, and cheese, pork by the hog, beef and pork in barrels or larger casks, live cattle, sheep and hogs) upon those or any other days of the week, shall be carried to the public markethouse of the said town, there to be sold at the stated market hours, to wit, from any time in the morning to twelve at noon.

No inhabitant, &c. to buy provisions during flated hours, but at the markethouse, &c.

And he it further enacted, That no inhabitant of the said town, or other person, shall presume to buy, or cause to be bought, of any person or persons bringing (and within one mile of the laid town) or having brought therein any kind of victuals or provisions for sale (except as before excepted) either upon the above stated market days, or any other days of the week, during the time of the above stated market hours, at any other place, whatsoever, but at or in the aforefaid market house, under the penalty of twenty shillings current money of this province for every such offence, to be recovered by warrant before any justice of the peace for Frederick county, or the county where such person shall reside, as in case of intall debts, to be paid to the flerk of the flaid market for the time being, and applied by him to the uses herein after mentioned:

IV. And be it further enacted; That no person whatsoever, bringing or sending, or having brought or fent, any victuals or provisions to the faid town for sale ket-house, &c. (except as Before excepted) shall presume to set, or cause to be sold, the said victimis or provisions, so bringing or sending, or brought or sent, as aforesaid, to the faid town, or within one mile thereof, at any other place whatfoever, during the time of the above stated market hours, but at or in the aforesaid market-house, under the penalty of ten shillings, current money of this province for every such offence, to be recovered, paid and applied as aforefaid. And if any servant or flave shall presume to sell any victuals or provision contrary to the true intent and meaning of this zetic such servant or slave shall be punished, by whipping on the bare back, at the difcretion of one or more justices of the peace for Frede-
