The Oath of Abjuration to be taken by all in Office.

Be it Enacted by the King's most Excellent Majesty, by and wish the Advice and Consent of his Majestie's Governour, Council and Assembly of this Province, and the Anthority of the same, That from and after the Conclusion of this present Sessions of Assembly, the Oath of Abjuration shall be administred to all persons that already have, or shall hereafter be admitted to have or enjoy any Office or Place of Trust within this Province, in such Manner and Form as is herein after recited, (That is to fay)

The Form

A. B. do Truly and Sincerely Acknowledge, Profess, Testify and Declare in my Conscience, before God and the World, That our Sovereign Lord King GEORGE is Lawful and Rightful King of the Realm of Great Britain, and of all other his Majesty's Dominions and Countries thereto belonging. And I do Solemnly and Sincerley Declare, That I do believe in my Conscience, that the Person pretended to be Prince of Wales, during the Life of the late King James, and since his Decease pretending to be, and taking upon himself the Stile and 'Title of King of England, by the the Name of James the Third, hath not any Right or Title whatsoever to the Crown of the Realm of Great Britain, or any other the Dominions thereunto belonging. And I do Renounce, Refuse and Abjure any Allegiance or Obedience And I do Swear, That I will bear Faith and true Allegiance to his Majesty KING GEORGE, and Him will Defend to the utmost of my Power, against all Traiterous Conspiracies and Attempts whatsoever, which shall be made against his Person, Crown or Dignity. And I will do my Best Endeavour to Disclose and make Known to His Majesty, and his Successors, all Treasons and Traiterous Conspiracies which I shall know to be against Him or any of them. And I do Faithfully Promise, to the utmost of my Prower, to Support, Maintain and Defend the Limitation and Succession of the Crown against him the faid James, and all other Persons whatsoever, as the same is and stands Iimited by an Act, entituled, An Act declaring the Rights and Liberties of the Subject and settling the Succession of the Crown to her present Majesty, and the · Heirs of her Body, being Protestants; And as the same by one other Act, entituled, An Act for the further Limitation of the Crown, and better Securing the Rights and Liberties of the Subject, is, and stands limited after the Decease of her Majesty, and for default of Issue of her Majesty, to the Princess Sophia. Electoress and Dutchess Dowager of Hannover, and the Heirs of her Body; being Protestants. And all these Things I do plainly and Sincerely Acknowledg and Swear, according to these Express Words by me spoken, and according to the plain and common Sence and Understanding of the same Words, without any Equivocation or mental Evalion or secret Reservation whatsoever. do make this Recognition, Acknowledgment, Abjuration, Renunciation and Promise heartily, willingly and truly, upon the True Faith of a So help me GOD. · Christian,
