Five Hundred Pounds of Tobacco, the one half to his Majesty, his heirs and Successors, towards the support of Government in this Province, the other half to the party grieved, or to him or them that shall inform or sue for the same, to be Recovered in the respective County-Courts of this Province where such Offence was committed, by Action of Debt, Bill, plaint or Information, wherein no Essoyn, Protection or Wager of Law to be allowed.

Neither shall the party so Ossending have any Appeal or Writ of Error, From which but the Judgment of the County-Court shall be Definitive therein; and Judgments of fines f the Clerk of the Provincial-Court of this Province, or any of the Clerks of Error to be of the County-Courts of this Province shall Issue out Process in Criminal allowed.
