the County, for the Use of the County aforesaid, such Servants Criminals as aforesaid, under the Penalties to such Master, Mistress or Dame refusing or neglecting to deliver up such Servants, as aforesaid, of making satisfaction to the County for all such Fees as by the County asoresaid, have been paid for such Criminals, as aforesaid, and such Sheriff to whom such Criminal Servant shall be Delivered, as aforesaid, is hereby required to receive and secure such Servants, Criminals, as aforesaid, so that he be and appear, at the next County Court to be held for the said County, to be disposed of, as the said Court shall consider.

An Act Causing Grand and Petty Jurors and Witnesses to Come to the Provincial and County-Court, and ascertaining their Allowances.

DE it Enacted by the King's most Excellent Majesty by and with the D advice and Confent of his Majesty's Governour, Council and Assembly of this Province, and the Authority of the same, That after the Publication hereof, the several and respective Sheriffs of the several and respective Counries within this Province shall cause to come before the Justices of the Provincial Court, two Men of the best and most understanding To the Provincial Free-holders of each respective County, to serve as Grand Jurors, and Court. three such like good and lawful Men of each respective County to serve as Petty Jurors at every Provincial Court; and the said Sheriff shall at return Pannels accordingly; and Twenty Days notice shall be given by the Sheriff to the Jurors, before the Day of their Appearance; and such Sheriff or Sheriffs as shall make default, shall be fined by the Justices he of the Provincial Court, One Thousand Pounds of Tobacco, to his Majesty, his Heirs and Successors, for the Support of the Government of this
