at such Time and Place appointed for Election, or shall make or cause to be made, any undue or illegal Election or Returns thereof, or Election and Reneglect to make Returns of the Delegates so to be Elected, by Indenture turns. before the Day of the sitting of such Assembly, pursuant to the direction on pain of Fine of the said Writs, shall for every such Fault be fined at the Discretion of exceeding 200 L. the Lower House of Assembly, next sitting after such Election, not Sterling. exceeding Two Hundred Pounds Sterling, One half to the Right Honourable, the Lord Proprietary, his Heirs and Successors, for the Support of Government, and the other half to the Informer, or to him or them that shall sue for the same, to be Recovered in any Court of Record within this Province, that may have Jurisdiction of the same, by Action of Debt, Bill, Plaint or Information, wherein no Essoyn, Protection or. Wager of Law to be allowed.

Provided nevertheless, That this Act or any thing herein contained, shall not Extend to be construed to Exclude any County or Counties, City or Cities, Burrough or Burroughs here af er to be erected and made ties, &c. hereafter within this Province, from the Liberty of such Elections of Burgesses, was Ereded. Desegates and Representatives, as is before expressed, but that such Writs, as aforesaid, shall upon calling every General Assembly of this Province, for the future, be directed to the Sheriffs of every fuch County, City or Burrough, when the same shall be erected and made into a County, City or Burrough, as aforefaid, and to the Mayor, Recorder and Aldermen of every fuch City or Borrough, Commanding such Sheriff or Mayor, Recorder or Aldermen to cause sour Free-men of the said County, and two Free-men of the said City or Burrough, qualified as in the aforesaid Writ is expressed, to serve as Delegates and Representatives of the same County, City or Burrough, in the General Which said four Delegates for every such Affembly next enfuing. County, and two for the City or Burrough shall from thence-forth be reputed and deemed to be Members of the Lower House of the General Assembly of this Province, any thing in this Act in any wife to the contrary notwithstanding.

And for the alcertaining, Limiting and Allowing unto the Several and respective Councillors, Deputies and Delegates that serve, or shall serve in the General Assembly of this Province, and of the several and respective Commissioners of the Provincial and County-Courts of this Province such Sum and Sums of Tobacco as is hereby thought necessary and sufficient sor desraying their: Charges in Attending such Assemblies and Aaa Courts.
