For Seal to a Proclamation of Rebellion, Three hundred and sixty Pounds of Tobacco.

For Seal of a Commission of Rebellion, Three hundred and sixty Pounds of Tobacco.

For Seal of a Grant of Land, for One hundred Acres or under, One hundred and twenty Pounds of Tobacco.

For every Hundred Acres above One hundred Acres, Twelve Pounds of Tobacco.

For Seal of a Decree in Chancery, Four hundred and thirty Pounds of Tobacco.

For Seal of an Injunction in Chancery, Two hundred and forty Pounds of Tobacco.
