

For Seal of a Patent of Denization, Four hundred and thirty Pounds of Tobacco.

For Seal of a *Ne exeat Provinciam*, One hundred and twenty Pounds of Tobacco.

For Seal of a Writ of Error from any County Court, One hundred and twenty Pounds of Tobacco.

For Seal of a *Scire facias* thereupon, One hundred and twenty Pounds of Tobacco.

For Seal of a *Supersedeas* thereupon, One hundred and twenty Pounds of Tobacco.

For Seal of every other Matter and Thing, that shall pass the Great Seal, and not herein contained, each, One hundred and twenty Pounds of Tobacco.

To the Commissary General, or Chief Judge in Testamentary Causes

FOR every Letter of Administration, or Letter Testamentary, One hundred Pounds of Tobacco.

For every Bond, Sixty Pounds of Tobacco.

For every Oath, Sixteen Pounds of Tobacco.

For a Warrant to Appraisers, Twenty eight Pounds of Tobacco.

For every Warrant to swear them, Twenty eight Pounds of Tobacco.

For every Commission to prove a Will, or to take Oath to account, or of Administration, One hundred Pounds of Tobacco.

For Recording Wills, Inventories, or Copying the same, or any other Matter out of the Commissary's Office, Sixteen Pounds of Tobacco, *per Side*, computing Seven Words to a Line, and Fifteen Lines to a Side.

For every Order in Testamentary Causes, Sixteen Pounds of Tobacco.

For every Citation, Twenty Pounds of Tobacco.

For Filing every Libel, Answer, Replication, Petition, &c. Forty Pounds of Tobacco.

For *Subpœna* for Costs, Sixteen Pounds of Tobacco.

For Drawing definitive Sentence, *per Side*, Sixteen Pounds of Tobacco.

For Filing of Costs, Sixteen Pounds of Tobacco.

For Copy of Costs, Sixteen Pounds of Tobacco.

For Recording definitive Sentence, *per Side*, Sixteen Pounds of Tobacco.

For Execution of definitive Sentence, *per Side*, Sixteen Pounds of Tobacco.

For Seal to the definitive Sentence, Four hundred and eighty Pounds of Tobacco.

For Seal to the Execution of such definitive Sentence, Two hundred and forty Pounds of Tobacco.

For Copy of every Answer, Libel, Replication, or Rejoinder, as before, *per Side*, Sixteen Pounds of Tobacco.

For Drawing Depositions of Witnesses, *per Side*, Sixteen Pounds of Tobacco.

For Filing Interrogatories, Forty Pounds of Tobacco.

For Entry of Demand for Administration, or Probate of Wills, Eight Pounds of Tobacco.

For Entry of every Return, Eight Pounds of Tobacco.

For every Appearance, Sixteen Pounds of Tobacco.

For an Attachment of Contempt, Fifty six Pounds of Tobacco.

For a *Quictus est*, One hundred Pounds of Tobacco.
