

Secretary's Fees.

- FOR a *Recordari*, Twelve Pounds of Tobacco.
 For a *Subpœna ad respondendum*, Three Names, Fifteen Pounds of Tobacco.
 For every Name more than Three, Six Pounds of Tobacco.
 For Attachment of Contempt, Eighteen Pounds of Tobacco.
 For a Proclamation of Rebellion, One hundred and twenty Pounds of Tobacco.
 For an Injunction, Sixty Pounds of Tobacco.
 For an *Audita querela*, One hundred Pounds of Tobacco.
 For a Writ of Enquiry of Damages, Forty Pounds of Tobacco.
 For a Writ of Covenant to pass a Fine, Fifteen Pounds of Tobacco.
 For a Commission to take Acknowledgment, One hundred and twenty Pounds of Tobacco.
 For a Writ of Assise, Thirty Pounds of Tobacco.
 For a Commission to fine Officers upon a *Melius inquirendum*, or *Monstraverunt*, One hundred and twenty Pounds of Tobacco.
 For a *Ne exeat Provinciam*, One hundred and twenty Pounds of Tobacco.
 For Drawing any Instrument that passes the Seal, if it exceed one Side, computing Seven Words to a Line, and Fifteen Lines to a Side, and so, *pro rato*, for more, Sixteen Pounds of Tobacco.
 For Recording the same as before, Sixteen Pounds of Tobacco.
 For Entering any other Matter upon Record, if it exceed Half a Side of a Leaf, Eight Pounds of Tobacco.
 If the Matter entered upon Record be above Half a Side, computing as before, for every Side, Sixteen Pounds of Tobacco.
 Copying the same, with Recording, Sixteen Pounds of Tobacco.
 For any Warrant or Licence against or to One Person only, not under the Seal, Fifteen Pounds of Tobacco.
 For any Warrant or Licence against or to more than One, not under the Seal, then for each Fifteen Pounds of Tobacco.
 For any other Pass or Discharge, not under the Seal, Fifteen Pounds of Tobacco.
 For Search of a Record, the First Year, Nothing.
 For Search of a Record above One Year standing, for every Year within the first Five Years, *per Annum*, Four Pounds of Tobacco; and
 For every Year above Five, *per Annum*, Two Pounds of Tobacco.
 For Filing every Bill in Chancery, Forty Pounds of Tobacco.
 For every Court the same shall continue, Four Pounds of Tobacco.
 For Filing every Answer, Thirty six Pounds of Tobacco.
 For every Oath to the same, Twelve Pounds of Tobacco.
 For Writing a Commission, a Bond, and Recording it, for every Sheriff's Office, Two hundred and forty Pounds of Tobacco.
 For Writ of *Posse Comitatus*, One hundred and twenty Pounds of Tobacco.
 For Writ of Discharge, if any, One hundred and twenty Pounds of Tobacco.
 For Writing and Recording a Commission, and *Dedimus Potestatem*, for the County Court, Three hundred and thirty Pounds of Tobacco.
 For every Writ and Return, Twenty eight Pounds of Tobacco.
 For every *Subpœna* and Return, Thirty eight Pounds of Tobacco.
 For Filing and Recording every Declaration, *per Side*, accounting Fifteen Lines to a Side, and Seven Words to a Line, Sixteen Pounds of Tobacco.
 For Copy of the same at the same Rate, not to be charged, unless required and delivered.
 For every Appearance entered, Twelve Pounds of Tobacco.
