**F**OR Swearing every Jury, One hundred and forty four Pounds of Tobacco.  
 For Swearing every Witness, Twelve Pounds of Tobacco.  
 For every Special Bail, Seventy two Pounds of Tobacco.  
 For every Good Behaviour, Seventy two Pounds of Tobacco.  
 For Clearing every Prisoner by Proclamation, Eighty Pounds of Tobacco.  
 For the Acquittal of every Prisoner, Eighty Pounds of Tobacco.  
 For every Appeal from the County Court, Fifty Pounds of Tobacco.  
 For every Writ of Error returned from the County Court, Fifty Pounds of Tobacco.

*To the Clerk of the Council.*

**F**OR every Petition in Council, and Order in Favour of the Party, Two hundred Pounds of Tobacco.  
 For any Commission, or other Instrument prepared by the said Clerk to pass the Broad Seal, if for a Place of Profit, Four hundred Pounds of Tobacco.  
 For every Sheriff's Commission, Four hundred Pounds of Tobacco.  
 For every Ranger, Surveyor, or Commission of Profit granted in Council, Two hundred Pounds of Tobacco.  
 For Recording any Matter in Council, *per Side*, for any private Person, Twenty four Pounds of Tobacco, and so, *pro rato*, for more or less.  
 For Copy of any Matter or Thing from the Council Records, the same *per Side*.  
 For all Searches, to the Clerk of the Council as is to the Honourable Secretary.

*To the Clerk of the High Court of Appeals.*

**F**OR Recording every Writ of Error, *Scire facias*, and Return, *per Side*, Twenty four Pounds of Tobacco, and so, *pro rato*, as before, Seven Words in a Line, and Twelve Lines in a Sheet.  
 The like for Recording a Transcript.  
 The like Fees for Recording the Errors.  
 For Entering and Signing Judgment, Eighty four Pounds of Tobacco.  
 For Filing a Bill of Costs, Twenty four Pounds of Tobacco.  
 For Copy of the same, Twenty four Pounds of Tobacco.  
 For all other Fees, as are taken in the Provincial Court Office.

*To the Clerk of the County Court.*

**F**OR a Writ and Return, Sixteen Pounds of Tobacco.  
 For every Declaration (if a Side) Eight Pounds of Tobacco, and so, *pro rato*, if more.  
 For Copy of the same, if demanded, as before.  
 For Entering of the Defendant's Appearance, Six Pounds of Tobacco.  
 For every Imparance, Four Pounds of Tobacco.  
 For Filing every Plea and Demurrer (if not a Special one) Four Pounds of Tobacco: If a Folio or more, *pro rato*; if any Copy delivered, *pro rato*.  
 For Entering any Matter upon Record, if Half a Side, Four Pounds of Tobacco; if more, then, *pro rato*, as before.
