An ACT for the Punishing the Offences of Adultery and Fornication.

B E it Enacted by the King's most excellent Majesty, by and with the Advice and content of His Majesty Com-Advice and Consent of H's Majestv' Governour, ouncil and Assembly son entertain of this Province, and the Authority of the Jame, That after the End any lend of this Session of Assembly, whoever shall, directly or indirectly, en- woman, or frequent her tertain, provide for, or cause to be entertained or provided or, any Company as lewd Woman or Women, or that shall requent her or their Company, ter Admonition, he shall after that Admonition to him or them he given by the Minister, or the be deemed a Vestry, or the Church-warden or Church-wardens of the Parish where such Fornicator. Persons shall inhabit, shall be adjudged a Fornicator or Adusterer as the Case shall be, and shall suffer such Penalties as by this Law is hereafter appointed.

And be it further Enacted, by the Authority, Advice and Confent aforefaid, That every Person or Persons that shall commit Fornication, and be son that shall thereof convict in the Provincial or County-Court, either by Confession Fornication, or Verdict of Twelve Men, shall be fined Thirty Snillings, currant shall be fined Money of this Province, or Six Hundred Pounds of Tobacco, by the 30 s. or 600 L Justices before whom such Conviction shall be, to the King's Majesty, his Heirs and Succelsors, for the Support of the County Charge.

And be it Enacted, by the Authority, Advice and Consent aforesaid, That every Person or Persons that shall commit Adultery, and shall be there- Every Person of convict, either by Confession or Verdict of Twelve Men, in the son convictof Provincial, or any of the County-Courts of this Province, shall be be fined 31. Fined by the Justices before whom such Coviction shall be, Three or 1200 l. of Pounds currant Money, as aforesaid, or Twelve Hundred Pounds of Tobacco, to the King's Majesty, his Heirs and Successors, towards defraying such County Charge as aforesaid.

And in Case the said Offenders or any of them, shall not have wherewith to pay the several Fines by this Act imposed, then the said Offender shall be adjudged to suffer corporal Punishment by Whipping upon his or their bare Bodies, 'till the Blood do appear, so many Stripes (not exceeding Thirty Nine) as the Justices before whom such Conviction shall be, shall adjudge.

Provided, That this Act shall not be construed to extend, as to the Bearers not Fine, to Women who have Bastards, and do resule to discover the Fa- discovering ther or Begerter of such Children, but that in such Case it shall be in the Father, the Discretion of the Justices before whom such Woman or Women may be whipt shall be convicted, either to take the Fine by this Act appointed, or to award Corporal Punishment; any thing in this A& before to the contrary notwithstanding.

And for the alcertaining what Women shall be accounted lewd, Be is Enacted by the Authority aforesaid, by and with the Advice and Consent a lewd Woaforesaid, That it shall and may be lawful for the Minister, Vestry and man, by As-Church wardens of any Parish where there is a Minister, and for the sistance of the Volume and Church wardens where there is no Minister, hadens and Minister, Ve-Vestry and Church-wardens where there is no Minister, before any stry and Admonition by them, or any of them given, in Pursuance of the Di- Churchwarrections aforemention'd, to give Notice or cause Notice to be given to dens; and any Person or Persons, by them, or the major Part of them, suspected of to proceed.
