

and continue to sell Liquor as an Ordinary-Keeper, shall be liable to the Penalties mentioned in this Act, against Persons selling Liquors without Licence; and it shall also be lawful for the Justices, to refuse granting such Persons Licences for that Year, and if they shall think fit to grant the same, at the next or other Court following, the said Ordinary-Keepers shall pay the full annual Charge for such Licence. Provided, that any Person, not having before had a Licence to keep Ordinary, may at any Court, other than August Court, have Licence granted, if the Justices see fit, but to continue no longer than the August Court following, when it shall determine and may be renewed as others; for taking of which Licences, the Ordinary-Keeper shall pay only in Proportion between the Time of his taking such Licence, and August Court aforesaid.

ALL and every Person taking Ordinary Licences as aforesaid, shall at the Time of having such Licence granted, pay to the Sheriffs of the respective Counties, where such Person or Persons shall inhabit, the Fine or Sum to be paid for Ordinary Licences; which the respective Sheriffs are ordered to receive and collect, as well as all the Fines and Forfeitures arising on the Breach of any part of this Act, by such Ordinary-Keepers; for receiving, paying and collecting of which Forfeitures, the said Sheriffs shall be allowed a Salary of *Five Pounds per Cent*; and the Clerk of each respective County shall keep a true and exact Entry of all Ordinary-Keepers, to whom Licences are granted, and of all Fines and Forfeitures relating thereto, and shall at every November Court deliver to the Justices, a true List of the Ordinary-Keepers and Fines and Forfeitures that shall happen that Year; and shall cause the like List to be delivered yearly, before the Twenty Fifth of December to the Trustees for emitting Bills of Credit.

AND the said several and respective Sheriffs, are by this Act obliged and required to pay all such Sum or Sums of Money, as shall come to their Hands by Virtue of this Act, for Ordinary Licences or Fines and Forfeitures as above, to the Commissioners or Trustees aforesaid, on or before the last Day of April yearly, during the Continuance of this Act, to be by the said Commissioners or Trustees applied to the replacing the aforesaid Sum of *Four Thousand Five Hundred Pounds*, so as aforesaid taken out and applied. For which said Licence and Recognizance to keep good Order and Rules as after directed, every Ordinary-Keeper shall pay to the Clerk of each respective County Court, the Sum of *Three Shillings* and no more.

THE Justices of the several County Courts are authorized and empowered, yearly at their August Court or oftner, if they think fit, to set and assess the Rates and Prices of all Liquors and other Accommodations whatsoever, in current Money, by the Ordinary-Keepers to be vended for the Year ensuing, and so yearly and every Year; which Rates and Prices of all Liquors and all other Accommodations, shall by the several County Clerks be transcribed and set up at the several County
