County Courts, in some publick Place, that any Person may peruse the same; and a Copy whereof, every Ordinary-Keeper is obliged to affix and set up in the most publick and convenient Place of their Houses, for the Perusal of such Persons as receive any Ordinary Accommodations, under the Penalty of Five Tounds current Money, to be collected, paid and applied as aforesaid; and on Nonpayment thereof, shall be sued in his Lordships Name, by Bill, Plaint or Information, or Presentment of the Grand Jury, without the Formality of an Indictment. For which Table of Prices, every Ordinary-Keeper shall pay the County Clerk Tawa Shillings and no more. And every Ordinary-Keeper or Inn-Holder, who after the assessing and setting up the Rates and Prices aforesaid, shall directly or indirectly take, exact, demand or receive for any Liquors or other Accommodation, above the Rates and Prices so assessed, for every such Account, so charged, sued for, taken or received, such Ordinary Keeper or Inn. Holder shall forseit and pay the Sum of Fifty Shillings current Money, to be collected, paid and applied as aforefaid; and in case of a Suit on tuch Account, shall be Nonsuit and pay the Defendant his sull Costs of Suit; and for every such Account paid and satisfied to any Ordinary Keeper, a fingle Magistrate, upon complaint to him made by the Party injured, may in a summary Way, order and compel to restore to the Party injured, the whole Sum so before had and received and his Cost, on complaint. The said Forseiture to be recovered in his Lordships Name before any Magistrate of the County, where the Offence shall be committed, as in cale of small Debts.

THE Party grieved shall be a legal Witness, (being under no Incapacity of being a Witness in other cases) to prove any Exaction or Extortion contrary to this Act.

EVERY Ordinary-Keeper or Inn-Holder so to belicenced as aforesaid, shall within Six Months after granting their respective Licences, be obliged to provide and maintain, if they keep Ordinary at the Court House in any County, sour good and substantial Beds, if at the City of Annapolis six good Beds, over and above what is for their own Family's Use, with sufficient warm covering for the same, and Indian Corn, Oats, Hay, Straw and stabling for ten Horses at the least; and if kept at any other place in the County, than at the Court House, shall within the Time aforesaid, provide and keep three spare Beds, with covering, and sufficient stabling and provender for fix Horses at least, under the Penalty of Ten Pounds current Money, one half to the Commissioners, to be by the Sheriffs collected and paid them, and the other half to the Person who will sue for the same. It is provided, that no Person so licenced to keep Ordinary, shall during the Time of their so keeping Ordinary, be Delegates, Justices of Peace, Attornies, Deputy Commissaries, Clerks, Sheriss, Deputy Sherists or Jury Men, or hold any other publick Office within the Province.
