

Act for preventing the Exportation of Tobacco out of the Province by Land.

*This and all the Tobacco Acts till 1753, (except the Act for preventing the clandestinely running of Trashy Tobacco) are fallen, and the Laws in them contained, are provided for and included in the Inspecting Law that Year.*

Act requiring the Agents of Lord Baltimore, to certify into the Secretaries Office, the Instructions and Conditions of Plantations with the Fees by them demanded, and obliging deputy Surveyors to Qualify.

NOVEMBER 29th, 1708.

Act confirming and explaining the Charter of Annapolis.

OCTOBER 28th, 1712.

Act restraining Victuallers and Keepers of Publick Houses from entertaining Sailors, to the prejudice of Trade.

*This Act is repealed March 20th 1743, but is re-enacted, and contained in the Act regulating Ordinaries.*

Act for relief of Debtors, and ascertaining the manner of tenders in Tobacco.

*The tender by this Act regulated is now better provided, and regulated by the Inspecting Law, so that now it has fallen.*

Act for Killing of Wolves, Crows and Squirrels, all Acts following hereon are with this expired, as there are no Counties where the Law now is in Force, except in Cecil, Kent and Queen-Ann.

APRIL 6th, 1715

Act Prohibiting the Importation of Bread, Beer, Flour, Malt, Wheat, Grain or Meal, Horses, Mares, Colts or Fillies, from Pennsylvania repealed 1728.

Act for the punishing the Offences of Adultery and Fornication. The Corporal Punishment Enacted by this Act is repealed May 24th, 1749, the residue stands in Force, and is insert in the Abridgment.

Act for the better Administration of Justice &c. All the Amerciaments in this Act, are repealed October 10th, 1722, and therefore not insert in the Abridgment where you have all in Force in this Act.

Act to confirm and make valid all manner of Process in the several Courts of the Province, from Queen Ann's Death. Temporary.

Act providing what shall be good Evidence to prove Foreign and other Debts, and to prevent vexatious and unnecessary Suits at Law pleading discounts in Bar, &c.

*This Law is repealed and re-enacted 1729, which see in Abridgment.*

Act for the speedy recovery of small Debts out of Court before a single Justice of the Peace, expired and re-enacted 1753.

Act for securing Persons Right to Town Lands.

Act for laying an Imposition on Negros, and on several sorts of Liquors.

*The Duty in this Act on Liquors is repealed, and the Duty now settled by Act past March 6th, 1758.*

Act for continuing Processes on the Change of Government from the Crown to the Lord Proprietary
