

TABLE of the ACTS.

MAY 28th, 1717

Act for regulating Ordinaries

This with all the other Laws relating to Ordinaries, till 1746, are expired when in the Act for taking £. 4500 out of the Loan Office, the Rules and Laws for Ordinaries are regulated.

All Acts for Adjournment of Courts are not inserted as Temporary.
 Supplementary Act for Limitation of Officers Fees, expired 1724.
 Act for disabling Mr. *M'Nacnemara*, to practice the Law, private Act.
 Act for the relief of those who suffered by the burning the Records of *Ann Arundel County* in 1704.

OCTOBER 10, 1722.

Act for uniting Part of *St. Paul's Parish* in *Baltimore County* to *Westminster Parish* in *Ann Arundel County*.

Act for the relief of Poor Prisoners. Expired.

Act for Limitation of Trespass and Ejectment not in Force, being dissented to by the Lord Proprietary.

SEPTEMBER 23d. 1723.

Act for the Advancement of Justice, expired and re-enacted in the Year 1752, which is inserted in Abridgment.

Act for the Encouragement of Learning, and erecting Schools, not insert as a Publick Act.

Act for the Trial of all matters of Fact in the several Counties where they have arisen.

This and all the Acts relative to the Court of assize, have fallen and are expired 1753.

Act reviving and continuing an Act for Limitation of Officers, and for supplying some defects therein.

This Act is expired, except the regulation that the Sheriffs were to take only one Execution Fee against one Person tho' arrested at the instance of several.

OCTOBER 6th, 1724.

Act securing against Impositions by *Ridlesden*.

Act for Erecting a Town at *Joppa*.

Act to invest the Vestry of Great *Choptank Parish* with an Estate in Fee Simple for building a Church.

As those Publick Acts do not contain any material Law, I omit the mentioning their Tittlings any further.

Act to restrain the ill Practices of Attornies &c. repealed and re-enacted 1730, but now fallen, and dissented to by the Lord Proprietary.

OCTOBER 10th, 1727.

Act for ascertaining the Form of the Oath of Judge or Justice, re-enacted 1728, when dissented to by the Lord Proprietary, but past into a Law 1732.

OCTOBER 3d, 1728.

A Supplementary Act to the Act entituled, An Act for the Establishment of Religious worship, dissented to by the Lord Proprietary.

JULY 13th, 1731.

Act to remedy defective Probats of accounts.

Temporary.

MARCH 1734.

Act for Naturalization. expired.

Act for licensing Pedlars and Hawkers. expired, re-enacted 1754.

MAY 24th, 1749.

Act for the relief of Persons accused and acquitted, and of Witnesses against Persons accused, expired, 1752.
