

Monday of March next, provided nevertheless, that if the president and directors of each and every incorporated bank as aforesaid, shall redeem the notes of a less denomination than one dollar, issued by each and every bank respectively, when presented to the amount of _____ dollars for payment, with specie, then the said charter of each and every bank, complying with the terms of this proviso, shall be and remain in full force and virtue in law."

On motion by Mr. Dennis, the said amendment was amended by striking out "first day of March next" and inserting in lieu thereof "end of the present session."

Mr. Potts moved to amend the said amendment by striking out "first Monday of March next" for the purpose of inserting "first Monday of July next?" Determined in the negative.

On motion by Mr. Long, the question was then put to amend the said amendment by striking out the first Monday of March next, for the purpose of inserting the "first Monday of May next?" Resolved in the affirmative.

On motion by Mr. Blakistone, the question was put, That the blank in the latter part of the amendment be filled up with "one thousand dollars?" The yeas and nays being required appeared as follow:
