in, the resolution therein contained assented to, and sent to the senate.

Mr. Yates delivers a bill, entitled, An act to prevent swine and geese from going at large in the town

of Hancock, Washington county; which was read.

Mr. Pigman delivers a petition from the vestrymen of the German Lutheran Congregation in Fredericktown, praying for a law authorising them to hold certain real and personal estate devised to them by Michael Boyer, in trust for thouse of the said congregation; which was read and referred to Messrs. Pigman, Dówney and Hawkins. Also a petition from sundry inhabitants of Frederick county, praying for a law authorising a lottery to raise a sum of money for the purpose of repairing and finishing the school house near David Leister's fulling mill, on Deep Run; which was read and referred to Messrs. Pigman, Buckey and Hawkins.

The speaker laid before the house a report from the clerk of Kent county court relative to the attendance of the judges; which was read and referred to the committee of grievances and courts of justice.

Mr. Long delivers a bill, entitled, An act to allow William Waller, late sheriff and collector of Somer-set county, further time to complete his collection; which was read the first and second time by special order and passed.

The speaker laid before the house a report from the examiner-general of the western shore; which was

read and ordered to lie on the table.

On motion by Mr Yates, Leave given to bring in a bill, entitled, An act to allow mileage in certain cases to jurors in Washington county. Ordered, That Messrs Yates, Kennedy and Sweitzer, be a committee to prepare and bring in the same.

On motion by Mr. Semmes, Leave given to bring in a bill, entitled, An act to establish a bank and incorporate a company under the title of The Planters Bank of Prince-George's county. Ordered, That Messrs. Semmes, Claggett and Digges, be a committee to prepare and bring in the same.

Mr. Digges delivers a petition from Samuel Webb, of Prince-George's county, a revolutionary soldier,

praying relief; which was read and referred to Messrs. Digges, Somervell and Semmes.

Mr. W. R. Stewart delivers a petition from sundry inhabitants of Queen-Anne's county, praying for a bank to be established at Centreville in said county; which was read and referred, to Messrs. W. R. Stewart, Roberts and Harrison.

Mr. Semmes delivers a bill, entitled, An act for the revaluation of real and personal property in Prince-George's county. Also a bill, entitled, An act annulling the marriage of Thomas F. Ward and Ann Ward, of Prince-George's county; which were severally read.
