Mr. Johnson delivers a petition from Lewis Cockey Hunt, by Samuel C. Hunt his guardian, praying for a law confirming the last will and testament of Lewis Cockey, late of Baltimore county, deceased; which was read and enerved to Messis Johnson, Woodycar and Price.

The report in favour of John Long of Harford county, a revolutionary soldier, was read the second time, concurred in, and the resolution therein contained assemted to, and sent to the senate.

The house resumed the further conside ation of the report on the petition of David Palmore. . On motion by Mr. Kennedy, the questi in was put, That the words " in conformity with the provisions of the act of assembly passed december session eighteen hundred and fourteen, be stricken out of the resolution, for the purpose of inserting the words " and to allow him full pay for lifer" Determined in the negative.

The report having been read throughout, the question was put, That the house concur therewith and assent to the resolution therein contained? Resolved in the afirmative.

Mr. Schnebly delivers a bill, entitled, An act for the relief of Henry Nyman of Washington county; which was read.

Mr. Pearce delivers a bill, entitled, An act for straightening a road in Sassafras Neck Cecil county; which was read.

Mr. Scott from the committee of claims delivers the following report: BY THE COMMITTEE OF CLAIMS.
