

The bill, entitled, An act authorising a lottery or lotteries to raise a sum of money for building a Masonic Hall and Church in New-Market, Frederick county, was read the second time by special order, passed, and sent to the senate.

The bill to authorise Sarah Harry, of Washington county, to sell and convey certain property therein mentioned, and the bill for the benefit of Levin Craig, infant child and heir of Margaret Craig, late of Dorchester county, deceased, were severally read the second time and passed:

The clerk of the senate delivers the bill for the revaluation of real and personal property in the counties therein mentioned, endorsed, will pass with the proposed amendment; which amendment was read. The bill for the relief of William Damsell, and the bill for straightening a road in Sassafras neck Cecil county, severally endorsed, will not pass. Also a bill, entitled, An act for the relief of Elizabeth League of the city of Baltimore, endorsed, passed by the senate January 14, 1818; which was read.

The house proceeded to the second reading of the supplement to the act, entitled, An act relating to inquests held by coroners, and after some time spent therein, in amending the bill, on motion by Mr. Harrison, the question was put, That the bill be recommitted to the committee who reported the bill? Resolved in the affirmative.

On motion by Mr. Eccleston, the question was put, That the house adjourn? The yeas and nays being required appeared as follow:

THURSDAY, January 15, 1818.

The house met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill for the benefit of Levin Craig, infant child and heir of Margaret Craig, late of Dorchester county, deceased, and the bill to authorise Sarah Harry of Washington county to sell and convey certain property therein mentioned, were sent to the senate.

Mr. W. R. Stewart delivers a petition from sundry inhabitants of Queen-Anne's and Kent counties, relative to the destruction of fish in the Chesapeake and its tributary streams; which was read and referred to Messrs W. R. Stewart, Wilson, Eccleston, Martin, Somerville, Jenifer and Pierce.

The bill to empower Thomas W. Griffith, late collector of Baltimore county, to complete his collections, and for other purposes, and the supplement to the act, entitled, An act to lay out and make public the roads therein mentioned in Harford county, and for other purposes, passed December session eighteen hundred and sixteen, chapter two hundred and eight, were severally read the second time, passed, and sent to the senate.

Mr. Tidball delivers a bill, entitled, An act to increase the allowance to the sheriff of Allegany county for keeping persons in gaol and finding them victuals; which was read.

The report on the petition of John Montle, an old soldier, was read the second time, concurred with, the resolution therein contained assented to, and sent to the senate.

Mr. Eccleston from the committee delivers the following report:

The committee to whom was referred the petition of Samuel Ringgold of Kent county, praying that a part of the land belonging to a certain James Hall, of Queen-Anne's county, may be condemned for the use of the said Ringgold's mill, have duly considered the same, and likewise the counter petition thereto, and are of opinion that the prayer of the said Ringgold's petition ought not to be granted, and that the petitioner have leave to withdraw his petition.

On motion by Mr. Wilson, Ordered, That the bill, entitled, A supplement to the act, entitled, An act to enlarge the bounds of Baltimore city, be made the order of the day for to-morrow.

Mr. Tingle delivers a bill, entitled, An act relating to the public roads in Worcester county; which was read.

Mr. Schnebly from the committee delivers the following report:

The committee to whom was referred the petition of Thomas M. Barney, beg leave to report, that they have had the same under consideration, and are of opinion that the prayer of the petitioner is reasonable and ought to be granted, and therefore recommend the following resolution:
