The committee to whom was referred the report and petition of the trustees of the Brookeville Acade. my, in Montgomery county, beg leave to report, that they have taken the same into consideration, and find that a few individuals in the vicinity of Brookeville have at considerable expense erected a spacious ... house for the instruction or youth; that the number of scholars at this time amount to seventy, and a number of applications for admission of others into said academy have unavoidably been rejected in consequence of the trustees not having funds to employ an additional teacher. Your committee are of opinion, that the institution, if fostered by public aid, would be of great public utility, but the state of the treasury being such, that any additional donation at this time to said county cannot be made, your committee beg leave to state, that a school at Rockwille receives annually eight hundred dollars, that from the best account they can get of the state of this school, the e are but few scholars in the English department, and has been for several years past fewer in that in which the languages are taught. If the embarrassed situation of the states funds will prevent a direct donation from the treasury, the committee would recommend the adoption of the following resolution:

Resolved, that four hundred dollars of the money appropriated to the use of the Rockville Academy, be paid annually by the treasurer of the western shore to the president and trustees of the Brookeville

Academy.
