The house proceeded to the second reading of the bill, entitled, An act relating to the public roads in Worcester county.

On motion by Mr. Lecompte, the question was put, That the 25th section of the bill be stricken out?

Determined in the negative.

On motion by Mr. Wilson, the following proviso was inserted at the end of the 25th section: "Provided no road, landing or lumber yard, shall be laid off under this law, through the yard, garden, building or orchard, of any person or persons, without his, her or their consent."

The bill having been read through ut, the question was put, Shall the said bill pass? Resolved in the

affirmative, and the bill sent to the senate.

The house resumed the consideration of the bill, entitled, An act to regulate lotteries. On motion by Mr. Kell, the question was put, I hat the house reconsider the first section of the bill? Resolved in the affirmative.

On motion by Mr. Kell, the question was then put, That the words, "provided however, that nothing herein contained shall be construed to extend to any lottery or lotteries in which any tickets have been sold, the prizes drawn therein to be nevertheless subject to the five per centum herein imposed upon all prizes," be stricken out of the second section for the purpose of inserting the following: "Provided, that the prohibition in this section contained shall not extend to the surgical institution lottery, or medical college lottery, the prizes drawn therein to be nevertheless subject to the five per centum by this act imposed upon all prizes." Resolved in the affirmative.

On motion by Mr. Kell, the question was put, That the house reconsider the third section? Resolved

in the affirmative.

Mr. Kell then novel to strike out the words "twelve hundred" in the said section, for the purpose of inserting "fifteen hundred."

Mr. Eccleston asked for a division of the question.

The question was then put on striking out? Determined in the negative.

On motion by Mr. Kell, the question was put, That the house reconsider the 5th section of the bill? Resolved in the affirmative

On motion by Mr. Kell, the words "except in the cases herein before provided for" were inserted after the word "drawings" in the 1st line of the 5th page.

On motion by Mr. Wilson, the words .. for each and every offence" were inserted after the word "dol-lars" in the 9th section.

On motion by Mr. Kell, the blank in the 11th section was filled up with "five hundred."

On motion by Mr. Kell, the words "for each and every offence" were inserted after the word "dollars" in the said section.

On motion by Mr. Blakistone, the words "mayor and city council" were stricken out of the 11th section, and the words "state of Maryland" inserted in lieu thereof.

On motion by Mr. Blakistone, the question was put, That the house reconsider the 9th section of the bill? Resolved in the affirmative.

On motion by Mr. Blakistone, the words "mayor and ve council" in the said section were stricken out and the words "state of Maryland" inserted in lieu thereof.

On motion by Mr. Wilson, the following was inserted at the end of the 11th section: "provided that nothing herein contained shall be construed to prevent the appointment of any manager of any lottery now authorised as lottery commissioner."

On motion by Mr. Kell, the biank in the 14th section of the bill was filled up with " five thousand dol-

On motion by Mr. Kell, the words "for each and every offence" were inserted after the word "dollars" in the sold section.

On motion by Mr. Kell, the blank in the 15th section was filled up with " fifty thousand."

On motion by Mr. Lecomple, the 19th section of the bill was stricken out.

The bill having been read throughout and amended, the question was put, Shall the said bill pass?

Resolved in the affirmative, and the bill sent to the senate.

The clerk of the senate delivers the bill for the preservation of bnoys in the Patapsco river and Chesapeake Bay, and the bill to provide for the appointment of trustees of the poor house of Baltimore county, severally endorsed, will pass. Ordered to be engrossed. The additional supplement to the act, entitled, An act to incorporate a company to make a turnpike road from Elkton to Christiana Bringe, endorsed, will pass with the proposed amendment; which amendment was read, agreed to, and the bill ordered to be engrossed. The additional supplement to the act, entitled, An act to establish pilots and regulate their ces, endorsed, will pass with the proposed amendment; which amendment was read, agreed to, and the bill ordered to be engrossed. The supplement to the act, entitled, An act to enlarge the bounds of Baltimore city, endorsed, will not pass. A bill, entitled, An act to incorporate the Hibernian Society of Baltimore; A bill, entitled, An act to establish a bank and incorporate a company under the title of The Bank of Somerset, severally endorsed, passed by the senace January 31, 1818; which were read. Also the following resolutions:

BY THE SENATE, January 31, 1818.

Resolved, That William Kilty. Thomas Harris, and John N. Walkins, esquires, be and they are hereby appointed to revise the acts of assembly of this state, and to prepare an edition thereof, including all public acts now in force, in the order in which they passed, from the end of the year seventeen hundred and ninety-nine till the end of the present session, inserting in the same order the titles of all private acts, and of such public acts as are repealed, have expired, or have ceased to have any operation, the time of such repeal or expiring of each law to be noted in the margin, as also the continuances of such acts as were originally passed for a limited time; to be accompanied with a full and complete index to the whole, compiled in the manner of the last edition of the laws of Maryland; that the said edition be completed within the present year, so as to be laid before the general assembly at their next annual meeting.
