The committee to whom was referred the petition of Thomas Ennalls, of Dorchester county, administrator of Joseph Ennalls of Henry, deceased, praying that a law may pass directing the sale of lot No. 1 of the Choptank Indian Lands, of which Joseph Ennalls of Joseph was the purchaser, and for whom the aforesaid Joseph Ennalls of Henry was the security, in order to pay the purchase money of the said lot of ground, or that some other measures might be adopted with a view to the speedy recovery of the said purchase money, and to the relief of the representatives of the security aforesaid, having had the same under consideration, are of opinion, that from the peculiar situation of the said property, and the right of those interested in it, that it would be improper at this time for the legislature to take any steps to wards the accomplishment of the object of the petitioner.
