So it was resolved in the affirmative and the bill sent to the senate.

The clerk of the senate delivers the bill for the relief of sundry poor out-pensioners of Anne-Arundel county; the bill for the relief of Catharine Freshour of Frederick county, and the bill to repeal an act, entitled, An act making a public landing place in Somerset county, and for other purposes, severally endorsed; will pass. Ordered to be engrossed. The bill to make valid a deed from William Mure, formerly of Saint Mary's county, to John Maddox of Saint Mary's county; the bill to alter and amend a road from Clement Green's Mill, in Harford county; the bill for the relief of Henry Nyman, of Washington county; the bill to empower the judges of the county court of Allegany county to reinstate the cause of John Hoblitzell, and others, against Martin Rizer, of Matthias, and the bill to authorise Sarah Harry of Washington county, to sell and convey certain property therein mentioned, severally endorsed; will not pass. The bill for the benefit of the heirs of John Brown, late of Montgomery county, deceased, endorsed, will pass with the proposed amendment; which amendment was read, agreed to, and the bill ordered to be engrossed. And the bill for establishing and building a bridge across Monocacy river, in the county of Frederick, endorsed, will pass with the proposed amendments; which amendments were read, agreed to, and the bill ordered to be engrossed. Also a bill, entitled, A further supplement to the act, entitled, An act directing the manner of suing out attachments in this province, and limiting the extent of them, endorsed, passed by the senate February 4, 1818; which was read the first and second time by special order and passed.

The bill from the senate, entitled, An act relating to the militia of Allegany county, was read the second time and passed.

Mr. Price delivers a bill, entitled, An act to authorise the levy court of Baltimore county to levy a sum of money for certain purposes; which was read.

Mr. R. Dorsey delivers a bill, entitled, An act for the relief of sundry poor out pensioners of Anne-Arundel county; which was read.

Mr. Lecompte from the committee delivers the following report:

The committee to whom was referred so much of the communication of the executive as relates to the collection of debts due to the state, beg leave to report a bill, entitled, An act to authorise the several district attorneys for this state to collect and receive all debts due the state," which is respectfully submitted to the consideration of the house.

Mr. Price from the committee delivers the following report:

The committee to whom was referred the memorials of certain citizens of Baltimore county, praying to have a sum of money levied to build a bridge over the Gunpowder Falls at Meredith's Ford, have had the same under consideration, and are of opinion that the authority given by the present legislature to levy several sums of money for repairing bridges in said county, which was carried away by the last August freshet, in addition to large levies still to be made for liquidating the debt incurred in building the court house, together with the law passed last session for annexing the precincts to the city, by which the county is deprived of the tax appropriated to repairing roads and building bridges, heretofore levied upon the city and precincts, and the ford over which the contemplated bridge was to be built is the best crossing place over the said Gunpowder Falls from Gwynn's mill to the mouth; under all these considerations, are of opinion it would be inexpedient to tax the county for the building the bridge as prayed for; they therefore propose that said petitioners have leave to withdraw their petition.

Which was read.

The house proceeded to the second reading of the bill, entitled, An act to authorise a loan to the state, and for other purposes.

On motion by Mr. Lecompte, the blank in the 1st section of the bill was filled up with "five hundred thousand dollars."

On motion by Mr. Woodyear, the words "at some one of the banks chartered by the state in the city of Baltimore," were inserted after the word "yearly" in the said section.

On motion by Mr. Lecompte, the word "eleven" in the said section was stricken out and the word "seventeen" inserted in lieu thereof.

On motion by Mr. Lecompte, the words "as herein after provided" were inserted after the word "applied" in the said section.

On motion by Mr. Lecompte, the words "in addition to the money now in the treasury, or which may be received therein from other sources during the present year, to defray all arrears or appropriations of the past year, and of the expenses of the state for the present year, which are or may be authorised by law, including the sum of twenty thousand dollars, with interest, borrowed from the Farmers Bank of Maryland," in the first section, were stricken out.

On motion by Mr. Lecompte, the words "or by the treasurer of the western shore in case no comptroller shall be appointed," were inserted after the word "treasury" in the 2d line of the 2d section.

On motion by Mr. Lecompte, the words "after the payment of the monies herein before directed in the first section of this act, the residue thereof," in the 2d section were stricken out, and the words "the money borrowed as before directed" inserted in lieu thereof.

On motion by Mr. Lecompte, the words "in the Union Bank, in the Mechanics Bank of Baltimore," were stricken out of the 3d section.

On motion by Mr. Lecompte; the words "in the Marine Bank" were stricken out of the said section.

On motion by Mr. Lecompte, the proviso in the said section was stricken out.

Mr. Lecompte moved to amend the bill by adding the following sections: "And be it enacted, that Robert Oliver, of the city of Baltimore, be and he is hereby appointed agent, and authorised and empowered to sell, under the direction of the governor and council, the reserved shares of the state in the Union
