BY THE SENATE, February 7, 1818.

Gentlemen of the House of Delegates,

We have rejected the resolution in favour of John Montle, (said to have been an old soldier,) because the certificate of the auditor accompanying the petition, instead of applying to *John Montle* certifies that *George Mondle* enlisted on the 4th of April seventeen hundred and seventy-eight, and was discharged on the first of November seventeen hundred and eighty, thus making it evident that John Montle is not entitled to a pension. If George Mondle is alive, and a resolution passed in his favour, the senate will concur in it if accompanied with the necessary vouchers.
