The bill for the benefit of Mary Mackubin of Anne Arundel county, was read the second time, passed, and sent to the senace.

The bill from the senate, entitled, A further supplement to the act, entitled, An act to establish a bank and incorporate a company under the title of The Bank of Somerset, was read the second time, passed, and returned to the senate.

On motion by Mr. Eccleston the following preamble and order were read;

Whereas, this day hath been appointed by his excellency the governor of Maryland a day of thanks giving and prayer, Therefore,

The question was then put, That the house adopt the preamble and order as amended? Resolved in he affirmative. The house adjourns until I o'clock P. M.
