Resolved in the affirmative and the resolution sent to the senate.

Mr. King presents a petition from the commissioners of the town of Princess Anne, in Somerset county, praying a confirmation of their proceedings; which was read and referred to Messrs. King, Dennis and Polk.

Mr. Forwood presents petitions from sundry inhabitants of Harford county, praying alterations in the law relative to roads; which was read and referred to Messrs. Forwood, Maulsby and Norris.

Mr. Key reports a bill, entitled, A supplement to an act to incorporate a company to make a turnpike road from the line of the District of Columbia, where it crosses the post road leading from George Town to Frederick Town, through Montgomery and Frederick counties, to Frederick Town; which was read.

Mr. Maulsby from the committee of pensions and revolutionary claims, delivers reports in favour of Levin Frazier, Edward Spedden, and Henry Perry; which were read.

The house, according to the order of the day, proceeded to the second reading of the further supplement to an act, entitled, An act to regulate the inspection of tobacco. On motion by Mr. Duvall, the question was put, That the house assent to the two first sections? Resolved in the affirmative.

On motion by Mr. F. M. Hall, the 3rd section was stricken out.

On motion by Mr. F. M. Hall, the question was put, That the 4th section be stricken out? Determined in the negative.

On motion by Mr. Duvall, the two last sections were stricken out.

The question was then put, Shall the said bill pass? Resolved in the affirmative, and sent to the senate.

On motion by Mr. Jenifer, the question was put, That the consideration of the Calvert contested election be resumed on Monday next? Determined in the negative.

On motion by Mr. Forrest, Ordered, That the same be resumed on to-morrow.

Mr. A. H. Price presents a memorial of the president and managers of the Baltimore and Harford Turnpike Company, counter to petitions relative to the same; which was read and referred to the committee on the petitions to which it is counter.

Mr. Dennis delivers the following report:

The committee to whom was referred the petition of Henry Hyland, and others, beg leave to report—that they have had the same under consideration, and are of opinion, that by the eighth section of an act, entitled, An act to declare and enlarge the powers of the courts of chancery, and the county courts as courts of equity, passed at December session eighteen hundred and eighteen, chapter one hundred and ninety-three, the county courts were invested with power adequate to afford the petitioners relief, and therefore that the prayer of the petitioners is inexpedient, and ought not to be granted; they therefore recommend that they have leave to withdraw their petition.

Mr. Maffett presents a petition from sundry inhabitants of Cecil county, praying for a change in the mode of collecting officers fees; which was read and referred to Messrs. Maffett, Kennedy and Wroth.

On motion by Mr. Maulsby, the following message was read, assented to, and sent to the senate.

BY THE HOUSE OF DELEGATES, January 21, 1820.

Gentlemen of the Senate,

We propose with the concurrence of your house, to proceed on Monday next at twelve o'clock, to an election of directors on the part of the state for the Union Bank of Maryland, the Mechanics Bank of Baltimore, the Commercial and Farmers Bank of Baltimore, the Farmers Bank of Maryland at Annapolis, the branch of the Farmers Bank of Maryland at Easton, the Hagers Town Bank, and the Elkton Bank of Maryland; and the following gentlemen are put in nomination on the part of this house for directors: For the Union Bank of Maryland, William Pinkney, Junr. and William Stansbury; for the Mechanics Bank of Baltimore, Tobias E. Stansbury and William Stuart; for the Commercial and Farmers Bank, Upton Bruce and John Barney; for the Farmers Bank of Maryland at Annapolis, William Kilty and Nicholas Brewer; for the branch of the Farmers Bank of Maryland at Easton, Lambert Reardon and Lambert Clayland; for the Hagers Town Bank, John Buchanan and Daniel Schnebly; and for the Elkton Bank, George Beaston. Messrs. Maulsby and Hayward are appointed by this house to join such gentlemen as may be named by you, to count the ballots and report thereon.
